

#### First Aldine edition of Pedanius's commentaries on Cicero's orations

**1. ASCONIUS PEDANIUS, Quintus.** Expositio in IIII orationes M.T. Cic. contra C. Verrem [&c.] (colophon:) Venice, heirs of Aldo I Manuzio & Andrea Torresano, December 1522. 8°. With Aldo's woodcut anchor and dolphin device on the title-page, repeated on the verso of the last otherwise blank leaf (each with letterpress "AL ... DVS" flanking the device), with spaces (with guide letters) left for manuscript initials, not filled in. Set in Aldo's famous italic (with upright capitals), the world's first italic printing type, first used in 1501 (showing the alphabet a-z and A-N in the register of quires above the colophon). Dark purple sheepskin (ca. 1880?). € 4500

First Aldine edition, in the original Latin, of a collection of commentaries on orations by Cicero by one of the most important Roman Cicero commentators of his time, Quintus Asconius Pedanius (9/3 BCE – 76/88 CE). The present edition was edited by Franciscus Asulanus, also known as Gian Francesco Torresani d'Asola, Aldo Manutio's brother-in-law (Francesco's father Andrea had been Aldo's partner and later his father-in-law, then ran the printing and publishing house from Aldo's death in 1515 to his own death in 1529). Pedanius's commentaries on the rhetorical works of Cicero were long lost until Poggio Bracciolini found a manuscript in 1416. Although that manuscript has since been lost, the commentaries found their way to the printing press and would eventually find their way to the general public in light of the humanist tradition, famously upheld by the Aldine press. Franceso Griffo cut Aldo's famous 1501 italic, which the press continued to use for many decades with minor revisions. The register of quires at the end of the present book conveniently shows a complete lowercase alphabet and the capitals from A-N. Since many passages are set entirely in capitals (sometimes half a page), the letters O-Z, not shown in the register, can easily be found in the text, except perhaps Y and Z. Aldo's heirs published a second edition in 1547 and Paolo Manutio published a third in 1550.

Binding slightly worn around the spine and corners, with some cracks in the hinges and a tear into the backstrip. Internally with only a few spots throughout and some slight marginal water stains in the last quires. Otherwise in very good condition.



HH Sheikh Hamad ibn Isa Al Khalifa, KCIE, CSI (1872–1942) was the King (Hakim) of Bahrain from 1923 until his death. Throughout the 1920s and 1930s, his palace in Al-Sakhir was a centre where both Gulf Sheikhs and British nobility and political figureheads were regularly invited to dine and discuss foreign policy of the region. The photograph shows the monarch in a deck chair on a ship in the company of noble retainers. The caption reads "Sheikh Hamad. Ruler of group of Islands Persian Gulf".


Rare first and only edition of a work on falconry, followed by a short treatise on cormorant fishing by Alfred Belvallette, "well known in France as a skilful falconer, and he writes with a thorough knowledge of his subject... French falconers apply the term *fauconnerie* only to

flights with the long-winged hawks (Peregrine, Merlin, Hobby, and Jerfalcon), flights with the short-winged Goshawk (*autor*) and Sparrow-hawk (*épervier*) coming under the expressive and very convenient term *autourserie*" (Bibl. accipitraria). The work partly contains original illustrations, including many photographs of falconers in action, but also copies of Schlegel and others.



Highly interesting collection of five 17th-century print series (one a set of plates for an illustrated book) all in the field of art, drawing and ornamentation. They seem likely to have been printed together sometime around or soon after 1688.



Ad 1: A beautiful print series intended as plates for a manual to learn the art of drawing and painting, ranging from images of the human body to battle fields, by the famous French artist Abraham Bosse (1602–1676). In the event the plates were published on their own and the makeup varies from set to set.

**Ad 2:** A numbered series of 30 engravings of ornamentation that could be used in sculptural, architectural, art and book illustration, including putti, grotesque masks, garlands, etc. Paolo Farinati (1524–1606) worked mostly in his native city of Verona.


**Ad 3:** A series of 4 prints showing artists at work, intended to illustrate art technique. Two are devoted to drawing and the other two are devoted to painting. These prints are often considered part of the larger series described here separately as ad 1.

**Ad 4:** A beautiful series of 4 prints representing the four elements in the form of two male and two female figures, elegantly dressed, with various items related to the relevant element. Blum tentatively dates the series to 1630, making it one of Bosse's earliest mature works.

Ad 5: A complete set of the plates made to illustrate the first and only edition of Pierre Bullet's work on surveying (Paris, 1688).

With a few plates (primarily in ad 2) spotted, but otherwise a good copy. The binding is somewhat worn and the front hinge cracked.



#### Handbook on building constructions by the designer of the first railroad in the Netherlands

Rare first edition of the first Dutch handbook on building constructions, also including the architectural orders by the civil engineer and architect Willem Christiaan Brade (1792–1858). Apart from interesting sections on laying foundations (underpinning), masonry, wood constructions including the construction of staircases, illustrations of the classical orders and many designs of public as well as private buildings (town halls, theatres, manor houses, etc.), the fourth volume is particularly devoted to the first railways, which were under construction in those years.

An additional, fifth volume to this series was published in 1844 (Amsterdam & The Hague, Van Cleef). This fifth volume is seldom found with these four volumes. A second enlarged edition appeared in 1842 in The Hague by the heirs of Dorman. Some soiling, browning and staining, part of plate 2 in vol. 3 missing, repaired tear in the left-hand part of this plate and another restoration in plate 14. Otherwise still an uniformly bound and rare set in good condition.

#### Extremely rare Spanish edition of a classic military treatise

Extremely rare second Spanish edition of the military treatise *I carichi militari* by the Neapolitan commander of the Habsburg armies in Italy, the Low Countries and Catalonia and aide-de-camp to Albert, Archduke of Austria, first published in Italian at Antwerp in 1610. The first Spanish edition appeared in 1639 and the third in 1710. It describes the duties and functions of soldiers and generals of the infantry, cavalry and artillery, as well as the sovereign's responsibility to ensure order within the military.

Contemporary handwritten owner's inscription on the title-page struck through. Later in the collection of Thomas Fremantle, 3rd Baron Cottesloe (1862–1956), commander of the Territorial Army and president of the Society for Army History Research. The invoice he received from Grafton & Co is loosely inserted. Binding with some water stains, hinges cracked. A few minor marginal defects, including tiny holes in the fore-edge margin of the first 75 leaves, not touching the text; a few marks in pencil. Almost unobtainable edition of a standard work: no other copy of any edition in auction records.

### Ordinance against robbery and violence perpetrated by whalers in the Davis Strait against the local Inuit

Ordinance against robbery, violence and even murder perpetrated by officers, whalers and sailors fishing in the Labrador Sea and Davis Strait, West of Greenland, against the local inhabitants, the indigenous Inuit peoples. The punishments are very severe and are explicitly stated at length, including the death penalty. It notes that violence is improper and illegitimate for a civil nation and an impediment to profitable trading and whaling.

The ordinance was reprinted in the Groot placaet-boeck (vol. v, 1725, pp. 1581–1582) which refers to it as: "Placaat, verbodt tegens doen van insolentie aan de bewoonders en naturellen der Straat Davids door onderdaanen van den Staat, den 18. November 1720".

In good condition. A very rare broadsheet: we have located no other copy.

### First edition of the most comprehensive work on integral calculus of its day, with 4 folding plates





First edition of the first extensive, separately published textbook on integral calculus, by Louis Carré (1663–1711), French mathematician and private teacher at Paris, published 44 years before Leonard Euler's classic textbook. It includes a wide variety of practical applications, including the measurement of surface areas, the determination of the volumes and centres of gravity of solid bodies, and problems of dynamics.

With a contemporary owner's name on the title-page, a later 18th-century manuscript note on the endleaf and a couple manuscript notes in the text. A failed attempt to wash out the owner's name on the title-page has left a small faint stain. With the title-page slightly foxed and an occasional minor spot, but still in very good condition and with very large margins. The binding shows some cracks in the hinges, superficial damage to the leather and some corners skilfully repaired, but is still good and structurally sound. The most thorough presentation of integral calculus to its date.

#### The most extensive Arabic catechism, with more than 1800 pages

First unabridged Arabic edition of the catechism translated from the Latin version authorized by the Council of Trent and the most extensive Arabic catechism ever published, comprising 1827 pages plus preliminaries.

It follows the Roman Catholic rite and was printed and published by the Propaganda Fide in Rome. It is based on the Latin text authorized by the Council of Trent under Pope Pius v, first published in Latin in 1566. While some small Arabic catechisms of a few dozen pages had been printed as early as 1580, only a few more extensive ones had appeared. The present edition is probably the most extensive Arabic work that the Propaganda Fide ever published.

With 19th-century library stamps. With occasional minor and mostly marginal foxing and an occasional quire slightly browned, but otherwise in very good condition, with only an occasional tiny hole or small marginal chip. Only slightly trimmed. The most ambitious Arabic catechism produced to this date.

Second copy located of the 1696 edition of Dirck de Hollander's standard revision of a standard Dutch mathematical exercise book (with answers) for use in schools. The present edition describes itself as the fifth, but is at least the tenth and probably little changed from the 1685 edition, which also called itself the fifth. All 17th-century editions are very rare, the STCN recording 3 copies of one (1664) and no more than 2 copies of any other (some are not recorded in the STCN at all). The simple assignments are designed to teach basic arithmetic and bookkeeping for practical commercial purposes. David Cock was an Arnhem school master, active as such in at least the years 1641 to 1652. His present text book was his most successful work, with many further editions and adaptations to 1799.



First edition, with the imprint changed to 1788 by pen, of the Dutch translation of Cook's account of his third and last voyage, with an engraved frontispiece depicting Cook's death by the native inhabitants of "Owyhee" (Hawaii). Cook (1728–1779) volunteered in 1776 for a third voyage "to investigate the coasts of the north Pacific, and to settle once and for all the question of the northwest passage" (Howgego). Via Cape of Good Hope, Tasmania and New Zealand they reached the Pacific Ocean, where they discovered and mapped several islands. They continued sailing north to the west coast of North America. Sailing south again they mapped some islands around Hawaii. After some natives had stolen one of the *Discovery*'s boats, Cook came ashore with a small party. The meeting escalated and during retreat Cook was overpowered by some native inhabitants and killed. Clerke gained command and set out to Kamchatka, but died along the way and was buried at Petropavlovsk. James King and John Gore were now in command of the two ships, and started sailing back to Plymouth.



First edition of Carlton S. Coon's account of his experiences in Ethiopia and Arabia. From 1933 to 1934 he travelled through Ethiopia to conduct physical anthropological research, but after conflicts with the authorities he had to escape to Arabia. Coon states in his foreword that the purpose of the present work is a memoir, since it was not meant to "impress the public with our scientific findings, for, interesting as these results may or may not be, they are reserved for more formal publication", but simply to tell what he and two others did during the expedition. Carleton Stevens Coon (1904-1981) was an American anthropologist and professor of anthropology at Harvard University and the University of Pennsylvania, who spoke 10 languages. He made notable contributions to the fields of cultural and physical anthropology and archaeology. He was the author of multiple works, including highly controversial works on race, such as *The origin of races* (1962). His theories on race were widely disputed in his lifetime and are considered pseudoscientific in modern anthropology.

A collection of 18 mostly unnumbered volumes of printed transcriptions of diplomatic correspondence, correspondence to and from British commissioners in the various courts, letters sent and received by judges in British vice-admiralty courts and naval officers at various South American, West African and Cape stations. Part of the reason for Britain's campaign to abolish the transatlantic slave trade in the 19th century was the establishment of several international tribunals of a continuing and more-or-less permanent nature to adjudicate upon vessels seized on suspicion of trading in African slaves after the trade had been declared illegal in the British Empire in 1807 (though slavery itself remained legal in most of the Empire until 1833). For all or part of the period from 1819 to 1871, mixed or joint commissions sat in Rio de Janeiro, Boa Vista (Cape Verde Islands), Suriname and Havana under treaties for the suppression of the slave trade that Britain had signed with Portugal, Spain, the Netherlands, Brazil, the United States and several Spanish-American republics. Courts of mixed commissions were responsible for the condemnation of over 600 slave vessels and the liberation of nearly 80,000 slaves.

The letters reprinted in the British parliamentary papers reveal the minutiae of the inner workings of the courts, their judges and clerks as well as the work of naval officers tasked with finding ships engaged in the illegal trade of slaves. Extensively covered in the documents was the work of local British officers reporting the results and latest court rulings to the foreign secretary and later Prime Minister Viscount Palmerston from as early as 1831. What those early letters

revealed was the rapidly changing attitudes towards the slave trade and forced labour in the still relatively young Empire of Brazil. The letters also give an insight into the social lives of recently freed slaves as they made their depositions at the court. Finding and condemning the slave vessels was at best an arduous and more often a downright dangerous task. Owners of slave vessels frequently tried to hide their ownership behind obscure transactions and renaming practices of the vessels or false flag operations. It was the task of the British commissioners and naval officers to try to uncover the network behind the Atlantic slave traders and seek to bring them to justice. On several occasions, the crew of the slave vessels did not hand over control over the vessels voluntarily, forcing the British commissioners to defend themselves during their mission. Yet it was of course the enslaved that suffered the most during the passages at sea. Frequently the letters and their detailed reporting on the route and the number of slaves onboard particular vessels allows the reconstruction of the route of a ship and the travails and suffering during its passage decimated those who had been forced on those hellish journeys.


Rare first edition of a pharmaceutical work by Jean Du Boys (ca. 1500–1576), describing everyday medicine as found in the works of the ancient Greeks and Arabs. It gives recipes for different medicines and the attributes ascribed to the medicines and herbs. Jean Du Boys was born at Lille, studied at Louvain and practiced at Valenciennes. In 1562 he became professor at the recently founded University of Douai. He is the author a few other works. As he is occasionally also called Sylvius, he is not to be confused with Jacques Dubois Sylvius (1478?–1555), teacher of Vesalius. 




Rare the first edition of a pharmaceutical treatise by the elusive physician Guillaume Dupuis (active 1536–1551) from Blangy in northern France but long settled in Grenoble. "Il ... exerca longtemps la médicine avec une grande réputation ... [et] était en même temps professeur à l'université de cette ville" (Hoefer). The work was republished in 1554, with a treatise by Cousinot, under the title *De occultis pharmacorum purgantium facultatibus*. Like most of its kind, it draws heavily on Galen and the Arabic tradition of Mesue.

Extremely rare pamphlet with the text – in French – of the Anglo-Dutch defensive alliance of 3 March 1678. In May 1672, French forces had invaded the Dutch Republic and initially seemed to have achieved an overwhelming victory (the so-called "Rampjaar 1672"). England supported France in what became the Second Anglo-Dutch (maritime) war (1672–1674). By late July 1672, however, the Dutch position had stabilized thanks to the new Stadholder Willem III. Concern about French gains led to the August 1673 Treaty of the Hague between the Republic, Brandenburg-Prussia, the Emperor Leopold and King Charles II of Spain; in early 1674 England and the Dutch made peace in the Treaty of Westminster. In November 1677 Willem III married his cousin Mary, niece of King Charles II of England. In the meantime, peace talks had begun in 1676 in Nijmegen resulting in an Anglo-Dutch defensive alliance, concluded on the 3rd of March 1678, almost a half year before the treaty was signed in August. But English troops arrived in significant numbers only in late May, allowing King Louis xIV to improve his negotiating position by capturing Ghent on the same day the alliance was concluded, on 3 March.



Three astronomical articles (2 in the form of letters) by England's first Royal Astronomer, John Flamsteed (1646–1719) at the Greenwich Observatory from its establishment in 1675, published in the *Philosophical Transactions* of the British Royal Society in the years 1683 and 1685. The first article gives observations of a 1682 lunar eclipse by Flamsteed himself, Edmund Halley and a certain Haynes. The second gives Flamsteed's calculations of the eclipses of Jupiter's four moons for the coming year 1686, intended in part as an aid to the determination of longitude. The third gives an engraved dial with four scales around its perimeter, with Flamsteed's description of its use to calculate the positions of Jupiter's moons..

Flamsteed's magnum opus, his great star catalogue and charts, appeared posthumously in 1725 and 1729, so his most important publications during his own lifetime were a single book in 1680 and a dozen short astronomical articles in the years 1672 to 1686, three of them present here.

The articles and plate have been disbound, but they are otherwise in very good condition, with only some minor spots in the text and a couple tears (one repaired). Three of Flamsteed's rare non-posthumous astronomical publications, with an engraved plate of his calculating dial.



Interesting collection of maps of the Beemster polder, which in the 16th century was an eight by nine kilometre inland sea north of Amsterdam. Its reclamation in the years 1607 to 1612, financed largely by the Dutch East India Company, was one of the most ambitious of the early 17th-century drainage projects. Dykes were built and the water was pumped out by 41 windmills, creating a large polder with sorely needed residential and above all farming land near the rapidly expanding city of Amsterdam.

Including: (Ad 1:) Apparently the last reprint, not reported in the literature, of a magnificent map of the Beemster Polder, on a scale of about 1:11,500, which "may be called the finest water-authority map of this era" (Fockema Andreae, *Gesch. Kartografie Nederland*, p. 36). The land was surveyed and the map drawn in 1640 by Balthasar Florisz. van Berckenrode and engraved in 1644 by Daniel van Breen. 

An atlas of 24 numbered detail maps and an overview key map with the general title, presented as a conveniently portable theatre-of-war atlas "pour la commodité de Mrs. Officiers" toward the end of the War of the Austrian Succession (1740–1748). It was based on the much earlier maps of Eugène Henri Fricx or Friex (1644–1730), revised and published by his nephew George Fricx or Friex in Brussels.

The maps could also be assembled to form a large wall map that would measure about 125 × 118 cm. It covers the southern parts of the Dutch Republic and the northeastern parts of what is now Belgium, covering The Hague and Leiden to Zutphen in the north and Brussels to Aix-la-Chapelle in the South. The atlas is undated, but the Newberry Library has a 1747 prospectus for it, issued by Guillaume Dheulland in Paris, who published a similar atlas of Italy with Julien in 1748 (though they did not share an address).

In the present copy the maps are bound as double-page maps with both ends folded in, giving the tall and thin agenda format.

The red pigment used to colour the edges appears to have browned the right-most fold of each map, and as a result several have torn along that fold. Otherwise the maps are in good condition, with a couple smaller tears only slightly affecting the image and marginal worm holes at the foot of a few maps, near the gutter. The binding shows some damage.



It is dedicated to Cardinal Francesco Barberini and presents the exercises on this subject that nine students (named in the book) at the College of San Pietro, in Montorio, carried out in the presence of the Cardinal. The assignment was to refute Quran passages on four subjects, where Germano believed it went against the Christian religion: supernatural guidance (p. 15), prayer and devotion (p. 19), the essential attributes of creation and the creator (p. 25) and extrinsic attributes of "Deo Salvatore" (p. 35). The pages progress from right to left, like a normal Arabic book.

The editor and guiding spirit of the publication, Dominico Germano (1585–1670), directed the College, taught Arabic at the Congregatio de Propaganda Fide since 1636 and collaborated on their Bible project. Born in Schnurgast, Silesia, he joined the Franciscan order in 1624, studied Arabic in Rome with Tommaso Obicini and lived in Palestine from 1630 to about 1635.



Very rare fourth(?) edition of a collection of treatises on fortification and siege craft, especially related to military mining, first published together in 1730. The main part consists of a treatise written by the Huguenot Charles Goulon (1645–1705). He had been one of Vauban's most talented officers and the chief of his miners. After the revocation of the Edict of Nantes he joined the Dutch army and subsequently, in 1693, the Imperial army. Goulon considered attack and defence as inseparable and in his treatise all examples are presented from the viewpoints of both the attacker and the defender. As a pupil of Vauban and a veteran of the Siege of Candia, the longest siege in history, Goulon was considered an authority by his contemporaries. Among the other treatises are two ascribed to Vauban. The one relating to the Siege of Ath (1697) is one of "the most important published sources" on this "epitome of Louisquatorzian siegecraft" (Ostwald).



Large manuscript map of part of the Lek River, near the village of Tienhoven in Zuid-Holland. The map was surveyed and drawn by Dirk van Hattum, the official surveyor of the water board of the Lekdijk Benedendams. In his map Van Hattum suggests the construction of a hydraulic works to improve the navigability of part of the river and simultaneously protect an elementary river groyne downstream. Besides the extent, nature and ownership of the lands, including the remains of former floodgates, much attention is given to the location, structure and improvement of the levee.

A concise description, mainly based on mathematical calculations, of how and to what extent to load mines with gunpowder, to undermine fortifications during a battle. It was written by J. J. H. (Johan Jacobus Hennequin), based on the work – formulas and calculations – of a lieutenant colonel with the miners and sappers, A. Eichholtz. Hennequin was inspired by Eichholtz's work and the fact that his calculations concerning the explosion of certain mines seemed to correspond with practical use by the miners and sappers of a battalion. Miners and sappers were the predecessors of modern-day military engineers and are still an important subgroup of these engineers.

Johan Jacobus Hennequin (1796–1880) was a lieutenant and adjutant with the aforementioned battalion of miners and sappers. He was the son of Pieter Hennequin (1765–1826) a military engineer/lieutenant engineer and later a general-major in the Dutch army.

Two rare early 16th-century Cologne imprints in a slightly later binding by the Breslau binder "HB", dated 1540. The first work is a popular manual on the rites of the Roman Catholic mass by Johannes Heynlin de Lapide (ca. 1425–1496) and the second work contains sermons by Augustinus of Leonissa (fl. 1435).

The binder, only known by his monogram "HB", is a Breslau binder active from 1525 to 1540, who is known to have made bindings for Johann Hess (1490–1547), Protestant reformer of Breslau, and for the humanist and diplomat Heinrich Ribisch, syndic of the city of Breslau and correspondent of Melanchthon. The present binding has two figurative rolls: the first showing the crucifixion, instruments of the Passion, and the resurrection of Christ, with the HB monogram (167 × 15 mm; could be similar to Haebler roll no. 6, but instead of the Man of Sorrows, it shows the Instruments of the Passion); and the second showing the four Evangelists with the HB monogram above the head of St. Matthew and the date at the top of the image of St. Marc (175 × 17 mm; Haebler roll no. 2).

With old owner's inscription on paste-down, owner's inscription struck through on title-page and several contemporary manuscript owner's inscriptions throughout, a few shaved by the binder, showing that they predate the 1540 binding. A good copy, with the blank lower half of the title-page cut off, some occasional browning and a few smudges, leaves D2 and D3 are slightly damaged in the upper outer corner, with only very slight loss of text in leaf D2. 


First edition of Jacob Mantino's translation into Latin of the fourth part of the first book of Ibn Sina's *Canon of Medicine* (original title: *al-Qanun fi at-Tibb*), divided into 31 chapters. Mantino dedicated it to the Doge of the Venetian Republic, Andrea Gritti (1455–1538).

Jacob Mantino (1490–1549) was a Jewish doctor, rabbi and philosopher. He was born in Spain, but he, his family and the Jewish community in Tortosa were forced to flee after refusing catholic baptism, as decreed by the catholic King Ferdinand II and Queen Isabella I of Spain. Mantino grew up in Italy and studied philosophy and medicine at the universities of Bologna and Padua. Most of his adult life was spent being a doctor to the pope and other prominent members of society like cardinals, bishops and ambassadors in Bologna, Verona, Venice and Rome. He was also involved in the (religious) controversy over Henry VIII's divorce from Catharine of Aragon. In 1549, just before his death, he moved to Damascus as ambassador of Venice. Mantino's intellectual production focused on the translation of scientific works from Hebrew and Arabic into Latin, especially medical and philosophical treatises by leading authors of the medieval period, including Moses ben Maimon (Maimonides), Ibn Rushd (Averroes), and Ibn Sina (Avicenna).

The present work was printed by one of the most successful and important late fifteenth and early sixteenth century Italian publishers Lucantonio Giunti (1457–1538). He was originally from Florence, but was active in Venice from 1489. He was a member of the Giunti family of printers, publishers and booksellers, who were active throughout Europe.

With owner's inscriptions on the front and back paste-downs and on the title-page, and some marginal annotations in brown ink. The paste-downs are partially covered by the newer, slightly foxed, end leaves. # First and only edition of one of the earliest works on Persian grammar

Rare first edition of a valuable Persian grammar (written in Latin), printed in Rome by the printing office of the Propaganda Fide. The third printed Persian grammar: only those of Louis de Dieu (Leiden 1639) and Greaves (London 1649) preceded it. Smitskamp, who refers to the present edition, though he had no copy to offer in his catalogue, notes that Greaves and the present author based their grammars "largely" on De Dieu's, but where De Dieu wrote for a scholarly audience, Ignatius produced a practical aid for missionaries in the field.

Ignazio di Gesù or Ignatius a Jesus, born Carlo Leonelli (1596–1667) joined the order of discalced Carmelites in Italy, who sent him as a missionary to preach the Gospel in Persia/Iran (1629–1641), where he lived in Isfahan and Shiraz and learned the rudiments of Persian, and in Mesopotamia, Syria and probably Turkey and Armenia. He is best known for his work among the Gnostic Christian Mandaeans (Christians of Saint John) near Basra, attempting to convert them to the Catholic faith. After more than twenty years, he returned to Rome and from 1652 to 1661 published accounts of his experiences in the East, helping to pioneer Persian studies in Europe. An account of his travels appeared in Melchisédech Thévenot's collection (*Relations de divers voyages*, 1663?). Though he had little training as an orientalist or a scholar, he wrote the present grammar based on information collected during his dozen years in Iran and it therefore forms an important source for the language as it was used there in the 1630s and 1640s.



First Dutch edition (second issue) of Ives's account of his voyage from England to India and his journey from Persia to England. From 1753 to 1757 the naval surgeon and traveller Edward Ives (1719–1786) was surgeon of the *Kent*, the flagship of Vice-Admiral Charles Watson, commander-in-chief in the East Indies. The squadron sailed via the Cape of Good Hope and Madagascar to India, where they visited the chief English settlements and major cities, Ives attending the company hospitals and staff in each place. When Admiral Watson died in August 1757, Ives's own health was also somewhat impaired and he resigned his appointment, travelling home overland from Basra, through Baghdad, Mosul and Aleppo, via Cyprus to Livorno and Venice, and finally through Germany and the Netherlands, arriving in England in March 1759 (ODNB). The plates include depictions of an altar, a Hooka (a Persian tobacco water-pipe, in the large folding plate), the tower of Babel, views of the forts St. David and Geriah, and an amulet with Arabic inscriptions, together with Dutch translations.





The first of the two contains observations of the currents for every square degree, with a distinction between the Guinea-current (which principal direction is east, printed in black) and the Equatorial-current (which principal direction is west, printed in red), and tables containing relevant information on, for example, the wind and temparature of the seawater. The second chart actually contains four smaller charts that are more detailed and show the currents under the influence of wind and other variables. The 24 charts are prefaced by a short introduction by P.F. Heerdt and a three page detailed explanation of the charts and their functions. All text is printed in Dutch and in French, any text in the charts themselves are only in Dutch.


The Royal Dutch Meteorological Institute was founded Utrecht in 1854 by meteorologist Christophorus H.D. Buys Ballot (1817–1890). The institute moved in 1897 to De Bilt, just outside of the city of Utrecht, where it is still located today. Since 1849, a total of 234 works on weather, currents, and general meteorological and climate subjects have been published by the founder of the KNMI until 1854 and from then on by the institute itself, the present work is number 78 in that series.


The book of the pearl by Georg Frederick Kunz (1856–1932) is one of the highlights of American gemmology from the beginning of the twentieth century. Richly illustrated with plates from various sources, some in colour, this is the presentation copy, inscribed by the author himself: 'To Miss Julia Halsey Munson, with the compliments of the senior author George F. Kunz New York July 10 1913'.

Kunz drew heavily on his encyclopaedic knowledge of gems for this book. The book of the pearl presents the history of pearls from ancient China to the author's present day. Kunz describes the historical and current practices of pearl harvesting and how pearls are processed into jewellery and cult objects. Kunz devotes much space to the region that he describes as 'the pearling center of the world' (p. 140): the Persian Gulf and the Red Sea. There lay the origins of pearl fishing in the Persian Gulf and Kunz describes the mastery of pearl fishers and pearl cutters of the region and the rich collections of pearls of Arab Shahs and princesses. He illustrates all of this through detailed maps. The text covers all aspects of ancient and modern knowledge of pearls, including the formation of pearls and the natural history of fresh – and saltwater pearls. John Sinkankis in his bibliography on gemmology praised the book as '[a] beautiful example of modern book design, executed in high quality materials [...] prized not only for the enormous amount of reliable information that it contains, indeed still unmatched in any work since, but also for the large number of high quality illustrations in black and white'. Georg Frederick Kunz was one of the United States' earliest gem experts. Born into a Swiss immigrant family in New York, he was primarily raised in New Jersey where he developed an early interest in minerals. He began collecting his first specimens by the age of 14. He had amassed a collection of approximately 4,000 stones only six years later. Kunz was a self-taught expert and his knowledge was second to none. He applied his knowledge as a gem expert for Tiffany & Company at the age of 23. He remained with Tiffany for 53 consecutive years, eventually becoming the company's vice president. During his career at Tiffany's, Kunz also became a prolific author. He is credited with a legacy of important books on gemstones. Kunz was also one of the founders of the New York Mineralogical Club, a Secretary of American Society of Arts and Sciences, an Honorary Curator of Precious Stones at the American Museum of Natural History, and a Curator for the New York Academy of Sciences. The pink gem variety of spodumene was named kunzite in his honour in 1903. Very good condition, only very slight wear to very slight wear to extremities, all plates included and intact, no browning






Drilling a pearl by means of the bow-drill

Unrecorded information guide for (new) employees of the Kuwait Oil Company (κοc) who would be residing in Al Ahmadi, headquarters of the Company. The Kuwait Oil Company was founded in 1934, a joint venture between the British Anglo-Persian Oil Company and the American company Gulf Oil. In the same year, the sheik of Kuwait, Ahmad Al-Jaber Al-Sabah (reigned 1921–1950) granted them rights to the oil concession, which they were to retain until 1975. The first oil was discovered in 1938 in Burgan field, followed by discoveries in Magwa in 1951, Al Ahmadi in 1952, and many more regions. In 1946 the first commercial shipment took place. Because the initial development of the κοc coincided with the end of the British Raj in India, many British and Indian people in its service were transferred to Kuwait, in particular to Al Ahmadi. Al Ahmadi was set up to house these workers.

This unrecorded guide is quite rare, especially because it seems to be a quite cheaply produced and ephemeral document which was issued only in small numbers for in-house circulation.

At some places very slightly frayed and creases along the edges and corners, staple a little rusted, leaves slightly toned, some leaves a little cut short at the foot (with no loss except for some of the catch-words, but overall in remarkably good condition. 

An exceptionally rare autograph note signed by the great French explorer La Pérouse. The extraordinary story and achievements of La Pérouse are well known, and recounted in the handsome official account of his expedition. However, because he was lost without trace mid-voyage, manuscript material relating to his life is very rare indeed. In the present note La Pérouse asks that his boat be given an impressive 286 "aunes" of canvas which is needed on board. An "aune" is an old-fashioned French measure usually translated as ell or cubit: its length could vary but the normal French/Parisian aune was about 118 cm, meaning that La Pérouse is in fact asking for about 340 metres of canvas. The sheer quantity of the request speaks to La Pérouse having written the note while in charge of a large vessel.

The document is counter-signed and noted as "delivered" by one "Deletombe": it seems very likely that this is Philippe-André-Joseph de Létombe, who arrived in the United States in 1781, and was the French Consul in Boston and a correspondent of Thomas Jefferson. If this identification is correct, the note would possibly date from La Pérouse's cruising in the West Indies and along the coast to Hudson Bay in 1781 and 1782.

First editions of the two primary botanical works by Peter Lauremberg, a scientist from Rostock (1585–1639), feature copperplate illustrations engraved either by Matthäus Merian the Elder or from his workshop. These works provide guidance on garden design, including valuable explanations about soil science, fertilization, pest control, planting beds, fruit cultivation, and garden tools, among other topics. They are widely regarded as highly influential works during their time. Lauremberg describes his own experiments and experiences, offering numerous well-founded and scientific instructions for cultivating and planting a wide range of beneficial plants. Additionally, he discusses the cultivation of fruit, flower, and herb gardens, as well as topiary and mazes. Merian's exquisite copperplate illustrations showcase garden tools used in the garden, as well as decorative figures for trimming bushes, hedges, and mazes, along with lilies.

This innovative horticultural treatise, featuring examples of garden design, was directly influenced by Vredeman de Vries. Lauremberg's notable contribution lies in his experimental proof of facts that were not yet accepted by botanists. The first part of the work primarily focuses on plant reproduction, compatibility between plants, propagation through seeds, stolons, and cuttings, as well as pruning, irrigation, and cultural techniques. The second part centers on orchards, flower gardens, herb gardens, and concludes with a list of medicinal plants. Merian's attractive plates illustrate contemporary gardening tools, 13 examples of raised beds (referred to as "pulvillus," similar to geometric plots in botanical gardens), four labyrinths of different shapes, and various garden tablets inscribed with mottoes, a backgammon board, and a sundial. The textual illustrations depict grafting and pruning techniques, along with intriguing topiary scenes. The allegorical title page combines emblematic figures and horticultural instruments within an architectural frame.



Jacob Le Mort (1650–1718), a Dutch chemist and physician, was an apothecary in Amsterdam before he moved to Leiden to set up a private laboratory where he also lectured. After many difficulties and fierce opposition, he was appointed professor of chemistry at Leiden University in 1702. He was the predecessor of the famous Boerhaave. 

First edition of a, mostly polemical, follow-up to the "unusually clear and highly systematic" (DSB) standard work on alchemy and early chemistry, *Alchymia* (1597), by the well-known German chemist Andreas Libavius (1540–1616). The present work, known as the *Syntagmatis*, consists of three separately published volumes (volume 1 and 2 second issue), each with a different title. In the first two volumes Libavius elaborates on his experiments in chemistry (illustrated with many woodcut illustrations of various sorts of glassware, vessels and other devices), followed by comments on the writings of Palmarius, Croll, Quercetanus (Duchesne) and many others. In the third volume, the appendix, he mentions controversies with Paracelsus, the Rosecrucians, Henning Scheunemann and Nicolas Guibert.





Third complete edition (the first under the present title) of a classic account of three voyages by the Scotsman William Lithgow (1582–1645?), mostly on foot, from Rome to Greece, Crete, Turkey, Cyprus, the Holy Land, Egypt and Malta, continental Europe and North Africa, and through the British Isles and the Iberian peninsula. He gives the earliest clear account of coffee drinking in Europe, describes Turkish baths and long Turkish tobacco pipes, pigeon post between Aleppo and Bagdad and the hatching of chicken eggs by artificial incubation.

The book went through more than a dozen editions in the course of two centuries. "He ... had a greater knowledge of the interior of the countries he visited than most travellers of this period. He provides interesting details of the society, men, and manners he observed" (Blackmer).



Rare complete set, in their first editions, of 2 works in Latin by Balthasar Lydius on old Christian movements that can be considered precursors of Protestantism and that influenced its origins, the second including as an appendix the Waldensian confession of faith, the text dated 1538 at the end. The whole is bound with an edition of Jan Hus's confession of faith, dated 1535 at the end. Georg Rhau at Wittenberg first published these two confessions of faith, apparently in 1538 and 1535. Though Lydius's second work is presented as a second volume to his first, they are often found separately. Balthasar Lydius (1576–1629), the son of a Reformed minister in the Palatine who was called to Amsterdam when Balthasar was a small boy, became himself a Dutch Reformed minister at Dordrecht, the epicentre of the most important religious reformation in Dutch history, which took place during his tenure (1602–1629). In this context the present works serve to prove a historical basis for Protestantism to aid in the theological discussions.

Berewout reissued his present 1616 Waldensia in 1622 and Niclaes Vincentsz van Spierinxhouck published Lydius's Dutch translation of the three works in a single edition at Dordrecht in 1624: Dry historische tractaetgens ... dienende tot verlichtinghe van de kerckelijcke historie.

Lydius's present works are rare and have been so for a long time, already in 1878 it was called a "rare and excellent work" (NNBW) The STCN records only 4 copies of volume 1, 2 copies of volume 2 (with the Waldensian confession of faith) and no copy of the 1617 edition of Jan Hus's confession of faith.



A detailed scholarly study of ancient sources for the history and geography of the Canary Islands, attempting to prove that the Portuguese discovered them before Islamic explorers, and that Islamic geographers knew them only through classical Greek and Roman sources. The main text is followed by extensive notes from a wide variety of sources and transcriptions of numerous primary sources, some in Greek or Arabic. In passing it also provides a wealth of information about navigation in the Mediterranean and Atlantic by classical Greek and Roman and by Islamic explorers. While Macedo's claim for Malocello's discovery of the Canaries in 1336 is no longer accepted, the Islamic geographer Idrisi noted a Portuguese voyage to the Canaries already before 1154.

### Letter by Pierre-Victor Malouet on the profit of colonialism in Saint-Domingue (Haiti) for Europe

Letter by the French colonialist and plantation owner Pierre Victor Malouet (1750–1814) to a French(?) member of the parliament, which he wrote as "deputy of the colony of Saint-Domingue". Saint-Domingue (now called Haiti) was a former French colony, until its independency in 1804. In this letter, Malouet describes the importance of America and colonies as Saint-Domingue for Europe and he also particularly gives attention to the merits of the American colonies and the poltical and economical implications of losing them. It was published during the Haitan Revolution (1791–1804), when self-liberated slaves revolted against the French colonial rule. Malouet is known as a counter-revolutionary colonist, who also signed for example the Whitehall Accord of 19 February 1793, which was an angreement that allowed colonist at Saint-Domingue as Malouet to maintain slavery, which was abolished by the French government.

Two large complementary wall maps of the seven Dutch provinces, covering (1) the provinces Holland, Utrecht, Friesland, Groningen, Overijssel and Gelderland and a part of Brabant, bound to the line Steenbergen – Roermond, and (2) Zeeland. Both are rare, especially the map of Zeeland. They were the first maps of the Netherlands on such a large scale, mostly about 1:105,000, but with some eastern regions squeezed in at about 1:140,000. Fully assembled, the map of "Hollande" would measure about 230 × 155 cm, and the map of Zeeland about 143 × 175 cm.


Originally published in 1748, Le Rouge's 21 plates for the two maps were revised for publication in a second state by Jean Crepy ca. 1770. The map in its present third state was revised and published by Jean A. Dezauche in 1790. On the back of each sheet is an engraved label with the sheet number and the name of the region covered added in manuscript.

From the library of Marco-Antonio III (1730–1800), Prince Borghese: on each box is the engraved armorial bookplate of the library of this Borghese Prince. Marc-Antonio's son, Camillo Filippo Ludovico (1775–1832), married Napoleon's sister in 1803.

Rare first and only edition of a manual of military strategy by the Lisbon-born Mendes de Vasconcelos, head of the Portuguese Eastern troops and governor of Angola from 1617 to 1620. The illustrations show battle formations, featuring rectangular oders as well as circle and star formations. This is the only known work printed on the estate "do Mascote" in Alenquer, a small town some 50 km north of the capital, by the prominent Lisbon printer Vicente Alvarez, who was active between 1607 and 1626 and whose productions include an edition of the great epic poem "Os Lusíadas" in 1612.

After Moreau's death, his script-types passed into the hands of other printers and were finally sold in 1787 to the 'Imprimerie Royale'.





A beautiful edition printed in Leiden, nominally published by Franciscus Raphelengius the elder, but in fact printed by his son Franciscus the younger and published by Christophe Raphelengius (1566–1600), grandsons of Christoffel Plantin, featuring parallel Latin and Greek texts, with commentary and translation by Konrad Rittershausen, a German publisher, jurist, and philologist. This work contains the Greek poems of Oppian of Anazarbus on fishing and those devoted to hunting by Oppian of Syria. The two poets were long confused. With the owner's inscription of Johann August Bechmann (1570–1632) on the title page, partially erased but still legible. He bought it in 1602 from the bookseller Froben in Hamburg, as noted in the volume and on the binding. At the time of his death in 1632, Beckmann was the rector of the princely school of Meissen, which still exists today as the Sächsische Landesgymnasium Sankt Afra zu Meißen. Bechmann made annotations throughout the work, with a particular focus on the preface by Konrad Rittershausen. He dwells there in particular on a passage evoking Plato's Republic. His handwritten notes on the endpapers provide valuable insights into his book buying and reading habits. Bechmann included an epigram by Salomon Frenzel von Friedenthal (1564–1605) at the beginning of the title, and also cites Jean Bodin's *Methodus ad facilem historiarum cognitionem*, comparing passages on the colour of lions in Ethiopia to Pliny and Oppian. As Bechmann notes at the end, it lacks the Scholia by Konrad Rittershausen that are normally included in this edition. He writes: "Hunc exemplari meo desunt, quod mihi comparabam Hamburgi apud M. Frobenium."

Lacking Rittershausen's Scholia, as noted, but otherwise in very good condition, some light browning, binding somewhat worn.





Extensive correspondence addressed to George Stanfield Blake, mainly from Leslie Reginald Cox, discussing fossil specimens. Blake's additional correspondents in the collection include the deputy director of the "laboratoire de paleontologie" of the French national museum of natural history J. Coltreau and the director of the British Museum of Natural History, C. Tate Regan.

Blake (1876–1940) was a British mineral and mining geologist and was from 1922 to 1939 the geological advisor to the Mandatory Government of Palestine, in which capacity he wrote and received the letters collected in the present portfolio. His work was essential, according to Israeli geologist Picard and others, for the expansion of geological knowledge concerning Palestine and Transjordan and their natural assets. Cox (1897–1965) was a British palaeontologist and malacologist (a specialist in molluscs), attached to the British Museum of Natural History and was elected a fellow of the Royal Society in 1950.

Most of the letters are typed with autograph signatures, but a few are autograph letters. Most of these autographs are incoming letters and thus are the original copy, not a carbon copy or draft version. The collection also includes a few illustrations of soil profiles and even some notes of thanks from the trustees of the British Museum of Natural History addressed to Blake, thanking him for providing information on fossils and the specimens themselves.

Paper wrappers show signs of wear, wrappers and documents inside are very slightly discoloured, most leaves are slightly frayed around the edges. Most leaves are numbered in blue pencil and the numbers correspond with the overview of the contents typed on a separate leaf, pasted on the inside of the front pink wrapper.



Nice copy of the rare first edition of one of the most successful books in the Delphin Classics, a series of annotated editions of the Latin classics, intended to be comprehensive. The first volumes were produced in the 1670s for Louis, Le Grand Dauphin, heir of Louis XIV and were written entirely in Latin. The grew to 64 volumes published from 1670 to 1698.

In 1668, the Latinist and lexicographer Pierre Danet (1650–1709) was appointed to the editorial team by Charles de Sainte-Maure, Duke of Montausier (1610–1690), tutor to Louis, Le Grand Dauphin. It was Danet who edited and annotated the present Latin fables of Aesop, in Phaedrus's verse translation, and added very extensive indices. All original volumes of the series included an engraving of Arion and the Dolphin. The Ad Usum Delphini series were reprinted for centuries, and served in classrooms across Europe and the Americas.





The preface is followed by a 5-page summary of the religion of the Ottomans.




Anonymous manuscript recipe book (ca. 1865), by a Dutch pharmacist from the Twente region in The Netherlands. The book contains about 150 leaves filled with manuscript recipes and formulas to cure animals. For example: a cure for a sow that will not let her piglets drink, or for a cow that retains her placenta. The book also contains recipes for humans (yellow fever) and domestic recipes like making piccalilli, several types of spiced wine and a trick to keep eggs fresh for months. With many lists of ingredients with prices. Mainly written in Dutch, but also French and German. Written in multiple hands, but the main and earliest one dates from 1862. Later dates are noted throughout, as well as some printed notes pasted in that date from the early 1900's. This indicates that the book had several subsequent users. Named places are Almelo, Borne, Oldenzaal, Deventer, Zenderen, Hengelo and Rijssen, which all lie in the rural northern Twente region. This recipe book gives an insight in Dutch rural life of the nineteenth century.





The extensive and authoritative work by Everhard van Reyd containing a comprehensive and detailed history of the first half (to 1601) of the Eighty Years' War (1568–1648) between the Netherlands and Spain. Jan Jansz at Arnhem first printed and published Van Reyd's account in 1626, twenty-four years after the author's death but long before the War came to an end with the Peace of Münster in 1648, under the title, *Voornaemste gheschiedenissen inde Nederlanden ende elders*. Although the first edition, like the later ones covered events upto the year before the author's death, the present second edition, beginning the title differently, notes that it has been checked against the author's manuscript and adds some parts of that were omitted in the first edition, as well as correcting printers' errors. It is therefore the first edition with Van Reyd's complete text and the first edition in folio format. The similar 1644 edition has some additions to the year of publication (obviously not by Van Reyd) and Van Reyd's nephews Johan and Frederik van der Sande prepared a new edition, published in 1650 (after Johan died), under the title *Historie der Nederlandtscher oorlogen begin ende voortganck tot den jare 1601*, but including a second volume with Johan's continuation, *Nederlandtsche historie*, ..., tot ... 1641.

With minor water stains in a few leaves (at the fore-edge of the preliminaries and the head of the index, that on one leaf somewhat more prominent and running across the lower outside corner of the text). The vellum tapes have broken at the joint of the back board, so that the binding has separated from the bookblock there (but the paste-down and free endleaf remain conjugate), and the binding shows a few smudges and stains and a small (I cm) defect on the back board, ties lost. Although the gilding is lost in a few places (especially on the spine and parts of the outer frame on the boards), sometimes with the impression smoothed away, most of the tooling remains very good condition, giving several crisp and clear gold-tooled impressions of each stamp and roll. One of the rare sets of all 3 parts of the English Reynard the Fox, the third part here in its first edition. The Reynard stories were already established as a coherent collection in the 12th century and were first printed in 1479, in a Dutch prose edition. They became especially well known when translated into English (and adapted) for Caxton's 1481 edition (in 43 chapters). The publisher Edward Alde in London began work on an extensive revision of Caxton's text, with many new additions, but he published only the first part, probably in 1620 (the first edition of the present part 1), containing 25 chapters, some corresponding with chapters in Caxton's edition and some not. Although the second part would have to wait 52 years, the first part quickly became the standard English version of the Reynard the Fox stories, with 8 editions from 1620 to 1671. Its language was modernized, giving both a view of the stories as they were known through most of two centuries and insights into English values and culture of the time. In 1684 Brewster added the present first edition of part 3, giving the adventures of Reynard's son Reynardine.

Possibly unrecorded variant of one of the three scarce Antwerp editions published in the same year as the first edition by Joos Lambrecht at Ghent in 1539, of an account of a so-called "Landjuweel", a rhetoricians' festival organized in Ghent in June 1539. They were organized by the chamber "De H. Drievuldicheyt" of Ghent and the 19 participating chambers from different cities each presented a play answering the question: "What is of the most comfort for somebody who is dying?" It was the first time that the texts of the plays were published immediately after the festival. The texts breathe the spirit of the Reformation and the book was banned in 1540.

The sequence of the three editions is not certain and the differences are minimal. Our copy has the title as described in Nijhoff & Kronenberg 3890, but contains a variant in the colophon: "xxv. Octob." instead of "xv. Octob.". This variant is described in the literature only as part of the other Antwerp editions, but because the variations in the title concern only abbreviations, many libraries may have catalogued copies improperly. Another edition appeared in 1564 in Wesel by Hans de Braecker.

A rare edition of the French translation of Rickman's account detailing James Cook's third and final voyage of discovery. The frontispiece is a close copy of that in the first edition; the chart, the same as in the first edition, is lacking in most copies: "the three copies examined all lack a chart" (Forbes). Rickman, Second Lieutenant on board the *Discovery*, published anonymously, to avoid legal action. He had managed to keep his journal, even though everything was taken into possession and sealed. His account is an important supplement to the official publication.

This lecture was published as part of the *Abhandlungen der Königlichen Preußischen Akademie der Wissenschaften zu Berlin* in 1824, but it was never bound as part of that volume, so it was apparently issued separately. Arabia Petrea consisted of the former Nabataean Kingdom in Jordan, southern Levant, the Sinai Peninsula and the northwestern Arabian Peninsula. In the present text, Ritter particularly discusses the Roman conquest of Arabia Petrea and the testimonies about it, but also describes it as a place of wealth and flourishing trade (particularly from Elath to Southern Arabia and India), with many populated cities and villages. Ritter also gives some geographical remarks upon Arabia Petrea, describing for example the landscape.



Apart from the Syrian flora and fauna and as the local climate, Russell's monograph discusses the everyday life of the local population, including that of European merchants living in Aleppo, the organisation of their trade activity, and their social life. He also includes a section on the plague and other epidemic diseases in the 1740s. The descriptions of the education system, the production of manuscripts, and the commercial activity in Syria are unusually detailed and unique in contemporary travel literature on the Ottoman Empire (cf. Chatzipanagioti-Sangmeister). The botanical plates were produced by G. D. Ehret, and one plate of fish bears the name of W. Skelton, while other plates, including those depicting birds and domestic life, are unsigned, but were probably produced by Russell himself.

Sixth (?) edition of Michel de Montaigne's (1533–1592) translation of the *Book of creatures* or *Natural theology* by the Catalan theologian Raymund of Sabunde (ca. 1385–1436). Written round 1436, "the *Book of creatures* belongs to the tradition of medieval works that follow the imperative according to which faith must evolve into seeking understanding. It was given the name of *Natural theology* because, as asserted in the prologue, it sets out to offer every human being the means of reaching the truth of Christian dogma, thanks to his own efforts, just by reading into the book of God's creation". However, although the book tries to guide the reader towards the fundamental truths of Christianity, basing itself on the visible order of creatures, it is halfway stated that since human nature is corrupt, the scriptures are more important and "God's word is to be believed in itself" (Habert).

Although the translation was commissioned by the Paris booksellers and appeared without Montaigne's name, it brought him his first fame as a man of letters. During his career he would return to Sabunde, publishing an Apology for *Raymund of Sabunde* among his famous Essays en revising his translation in 1580. First published in 1569, Montaigne's translation was reprinted several times, with the final edition appearing in 1641. After that the text would only reappear in 19th-century editions of Montaigne's complete works.



Huge volume containing an important collection of articles and papers on fish and especially eels, by the Danish biologist Ernst Johannes Schmidt (1877–1933), probably all his papers published in this period. Schmidt is best known for his findings on the migration patterns and breeding places of the eel, which he researched during various Danish expeditions in the North Atlantic Ocean and the Mediterranean Sea. He also, accidently, caught the first leptocephalus larva outside the Mediterranean Sea, which are also discussed in many of the papers. The book opens with a general title-page *Havundersøgelser* (Ocean studies), followed by a portrait, a letter and all the articles. Most of them are written in English, although a few are in Danish, German or French. Discussed in the articles are eels and their larvae, cod, halibut, sun-fishes and other fish, and one deals with various turtle species in the Danish West Indies. Many of the articles include illustrations in text, folding plates, maps and/or tables, showing migration routes, a fish's growth stages etc. Full list of contents available on request.





First bilingual edition of the oldest treatise on spherical geometry, providing the first edition of the original Greek and the first Latin edition to be translated directly from the Greek. It was composed by the Greek mathematician and astronomer Theodosius, perhaps around the year 100 BCE, and edited by Jean Péna (1528?–1558?), mathematician at the Collège Royale. The Greek text and very extensive notes, also in Greek, occupy the first half of the book, while the Latin translation of both text and notes (and repeating the woodcut diagrams) occupies the second half. The first two Latin editions (Venice 1518 and Vienna 1529) were translated from Arabic translations of the Greek, so the present book was a watershed in the development of Greek scholarship. Since spherical geometry was essential to the development of astronomy, it also set the stage for the Renaissance revolution set in motion by Copernicus, Gallileo and others. On top of that it was a monument to the golden age of French typography.







Includes a chapter entitled "Alpine excursions", describing the author's plant hunting activities. The chapter on Vienna, an account that historiography has surprisingly almost ignored, deals extensively with the local gluttonous eating habits first described (and since immortalized) by Aeneas Silvius Piccolomini three and a half centuries earlier. Townson continues to describe at length the imperial hothouses and zoo at Schönbrunn Palace. The book is also "a work valuable to the natural historian, particularly the mineralogist; it also contains a very particular account of the Tokay wines" (Lowndes).



Beautifully illustrated and finely printed second edition of a manual on garden planning and design by the French garden architect Narcisse Vergnaud (1794–1848), first published (also by Roret) in 1835. The finely lithographed plates show plans and views of the gardens of Blenheim, Buckingham, Windsor, Longleat, Chatsworth, Stowe, Chiswick and Lord Pembroke's estate at Wilton in England; the Pitti Palace at Florence; and Morfontaine, Malmaison, St. Leu, Beauregard at Villeneuve, Marly-le-Roy and Bougival in France; as well as some model designs of public parks.





Rare second edition (1st issue, in 2 volumes), extensively revised and enlarged, of a mathematical study of the construction of sundials, by Eberhard Welper the elder (1590–1664), first published in 1625 and here with useful additional observations and enlarged with a second part by Johann Christoph Sturm. Welper was born in Lohr (near Marburg), but studied in Strasbourg where he worked as a bookseller, printer, mathematician, astrologer and astronomer. The first edition of the present work was one of his earliest publications. Sturm greatly expanded Welper's *Gnomonica* for the 1672 edition, which was originally complete in the present two volumes. In 1681 Sturm added a third volume, so the present two volumes were reissued with the third. Doppelmayer added a fourth volume in 1708.


The drawing is signed "G.P. Westenberg" which suggests the Dutch artists George Pieter Westenberg (1791–1873) and the watermark is dated 1838. However, the signature does not match the signature on other drawings of Westenberg, who mostly signed "P.G. Westenberg". It does however match with a drawing in the Fléhite Museum in Amersfoort (inv. no. 1000–730), dated 1838–1839. Perhaps these drawings were done by Westenberg's son, also named George Pieter (1829–1880).

George Pieter Westenberg was a Dutch painter of landscapes and city views. Between 1838 and 1857 he was curator of paintings at the museum for contemporary art in Haarlem, after which he departed for Batavia in the Dutch East-Indies to become keeper of the privy seal. His identically named son accompanied him to Batavia and later moved to Tagal and Semarang.

# An outstanding description of various aspects of living in Bahia during the Second Empire (1840–1889) by a British vice-consul

First edition of Wetherell's extensive description of life in Bahia during the Second Empire (1840–1889) under Dom Pedro II. James Wetherell (1822?–1858) was a British businessman who lived in Bahia for 15 years beginning in 1843, serving as British vice consul (1843–1857). In short notes, he wrote about many aspects of Brazilian life, people and customs as religion (churches, convents, religious functions, ceremonies), means of transport (boats, canoes, carts), politics and economy, slavery, food and cooking, etiquette, fishing. He also describes largely natural historical aspects such as flora, horticulture, fruits, fossils and shells, insects and different mammals and birds. Besides this, Wetherell discusses Brazilian music and includes a lithographed sheet of music of a contemporary popular song. His many notes dating from 1852 to 1857 are considered to be very accurate and give a vivid and very good exemplary description of life in Bahia during the Second Reign, covering many different topics. The book is rarely offered for sale, the last two copies being at auction at 2019 and 1985.

A unique set of views from Zanzibar and Madagascar, taken five years after the French military intervention of 1894/95, also called the Second Madagascar expedition. The unidentified photographer can be seen in three of the photographs, wearing a white coat and white pith sun helmet, being the French tropical style as used by white colonial troops since 1878, suggesting the photographer's connection with the French colonial army. His travel partner is occasionally shown as well. Their visit took place during the final years of the notorious slave trading activities of Tippu Tip (1837–1905) in Zanzibar.


The photo album opens with a portrait of a young Sakalavan woman in a beautiful dress. Three other photographs show other native women as well, including one family with a baby. The majority of the photographs are panoramic views, showing villages, harbours, coasts and landscapes, the first dated 28 November 1900. The only full-page photograph in the album shows an Arab caravan marching along the beach. Rare are the few photographs taken in Mayotte, giving some highly uncommon scenes of the island nation's pre-development era.
