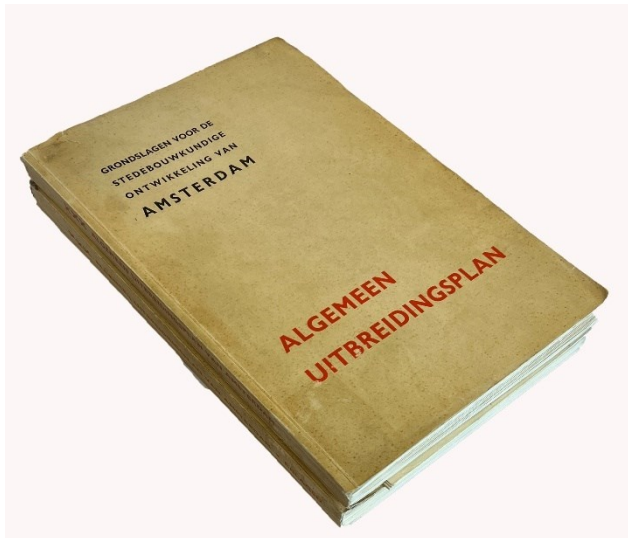

#299487 **Chinese Crime, Punishment & Torture.** Chinese glass-fronted box with original hand-painted Chinese drawings on pith. Oblong. 13x9 cm. In orig. glass-fronted box. ca. 1890-1910. Late Qing Dynasty, the last imperial dynasty of China, ruling from 1644 to 1912. Two paintings with small tears & 1 painting with a small hole. Illustrations not affected. With 12 hand-painted scenes, inspired on the famous and popular English work, "The Punishments of China" by Georg Henry Mason (1808). Pith 'paper' comes from the central column of spongy cellular tissue in the stem of

a small tree called *Tetrapanax Papyrifera*, native to south-west China, and is often confused with rice paper. There was a flourishing trade in pith paintings by the early 1830s. Developed to appeal to the 'foreign barbarian' visitors to China, paintings on pith were produced by artisans rather than by the intellectual elite and they were therefore not accepted as Chinese art. Painters on pith did not in general sign their work. The albums of pith paintings (and later the little glass-fronted boxes) were inexpensive, light, easy to pack and gave the pictures some protection on the long voyage home. Pith paintings in little glass-topped boxes were available in Hong Kong late in the nineteenth century and probably well into the twentieth. Because pith paintings were sold in albums and boxes and hence protected from the light, they retain their bright colours to this day. Condition : very good. € 750.00

The Treaty of Munster is the first time that Spain "conceded to another nation, in clear and explicit terms, and in a public treaty, the right to sail to, trade, and acquire territory in the West Indies." It ended the monopoly of Spain & Portugal on New World trade and colonization based on 15th-century treaties and Papal bulls, and is therefore an important treaty relating to the commercial development of the West Indies and European possessions in the New World. 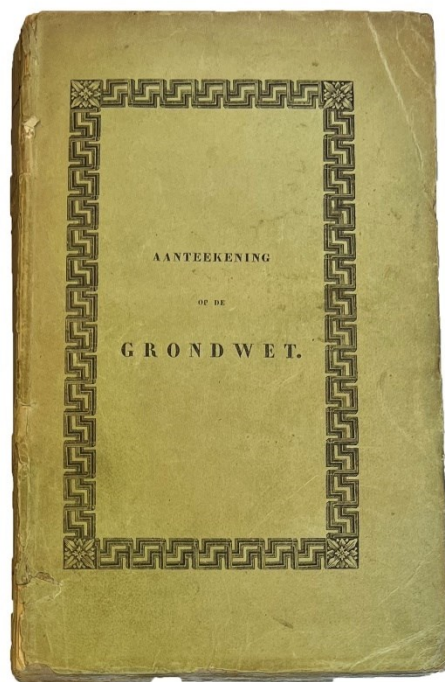

 36.5x24 cm. - Johan Brouwer trok naar Spanje met de bedoeling zich bij Franco's opstandelingen aan te sluiten en liep pas daar over naar de regeringstroepen, waar hij aanvankelijk als spion gearresteerd werd. Eind 1936 publiceerde hij een essay over De Spaansche Burgeroorlog : zijn oorzaken en mogelijke gevolgen, waarin hij een objectief beeld van de strijd tracht te schetsen. Daar kan men een vraagteken bijzetten. De fascist en hun doelstellingen worden met wat al teveel begrip en een zekere sympathie beschreven. Een wonderlijke zin is bijvoorbeeld ook: 'Het eigenlijke werk (in de strijd) is gedaan door het vreemdelingenlegioen en de kleurlingen, de Marokkaansche troepen. Men blijft deze naar Spanje overschepen, en het is een bedenkelijk feit, dat zulke strijdmachten het politieke stelsel, uitgedrukt in de leuze God, Vader- land en Koning, moeten grondvesten. 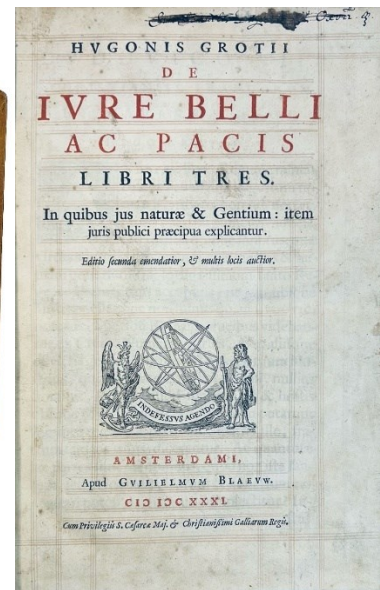

Very good clean copy in original state. - Dit boek heeft het fundament gelegd voor de vestiging van de parlementaire democratie in Nederland. In 1831 werd Thorbecke benoemd tot hoogleraar diplomatie en moderne geschiedenis aan de Universiteit van Leiden. Uit zijn daar gegeven college's over de Grondwet, ontstond deze publicatie : "Aanteekening op de Grondwet" (1839), zijn eerste openbare bijdrage aan het debat omtrent de herziening der grondwet, in 1841-1843 in een uitgebreide, herziene tweede editie nogmaals uitgegeven. Thorbecke wordt voorzitter van de door koning Willem II in 1848 ingestelde Grondwetscommissie met als opdracht een nieuwe Grondwet te ontwerpen. De reden hiervoor was dat koning Willem II geschrokken was van de politieke woelingen in het buitenland. De nieuwe Grondwet bevatte bijna volledig het werk van Thorbecke. Deze grondwetsherziening legde de basis voor het huidige stelsel van parlementaire democratie in Nederland, waardoor niet langer de koning, maar de ministers verantwoordelijk zijn voor het beleid. De Tweede Kamer der Staten-Generaal krijgt veel meer invloed en wordt bovendien rechtstreeks - weliswaar voorlopig nog door een beperkte groep kiezers - gekozen. The work also deals with the question of the internal government of States from an innovative angle; large passages are devoted to economic, commercial and demographic questions. Its impact was considerable from its publication and it remains today a universal reference. " Praised by his contemporaries throughout Europe as well as in America (the declaration of independence of the United States takes up its definition of state sovereignty). The work, which reintroduces a liberal vision inherited from Locke and Jurieu, exerted a decisive influence. "Having acquired an inexhaustible optimism from reading Leibniz, Vattel develops, on the relations between nations, on sovereignty, on the rights of peoples, ideas which will serve to found the liberal doctrine" (Patricia Buirette) (Camus-Dupin). , 202. 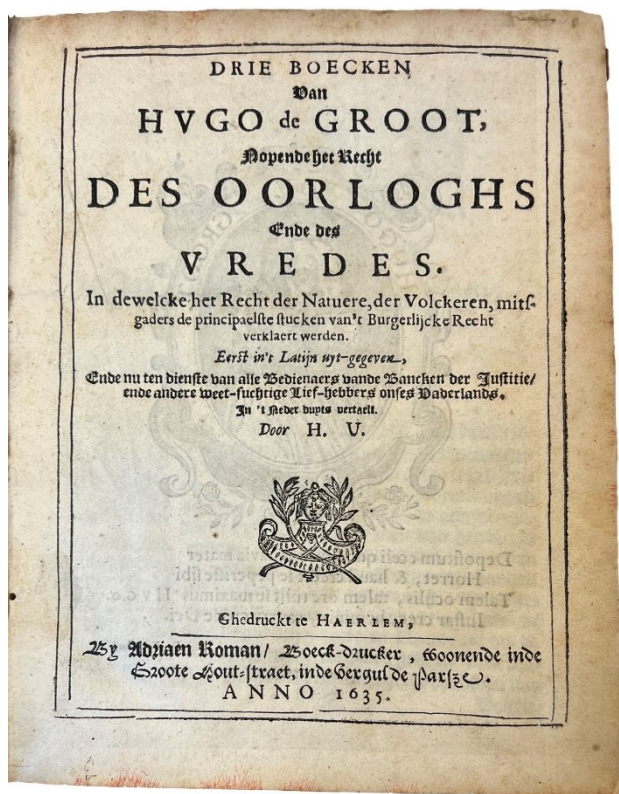

De Jure belli ac Pacis was first published in 1625 in a hurry by Nicolaus Buon in Paris and was presented at the Frankfurt Bookfair of that year, two corrected versions were published later in the same year. The German bookdealer Daniel Wechsel has bought copies of the first edition in Frankfurt, sold them all and initiated a corrected, unauthorized reprint in 1626. This pirate edition was a great success, and Grotius urges Buon to publish a new revised edition. Unfortunately, due to the death of Buon, this didn't happen until 1631. This edition, the first published in the Netherlands and Grotius's first revision of the text, was called the second edition to distinguish it from the pirated 1626-edition. In this 1631-edition Grotius made important changes and it became the reference text of this work for contemporary scholars. Later editions of 1632, 1642 and 1646 contain some revisions and additions, but are all based on this edition. According to Van Vollenhoven, this edition is the most important of the 5 editions prepared & supervised by himself. The standard text of today, the 'editio maior' published in 1939 and reprinted augmented with additional notes in 1993 is a reprint of this 1631-edition, with the changes added separately. 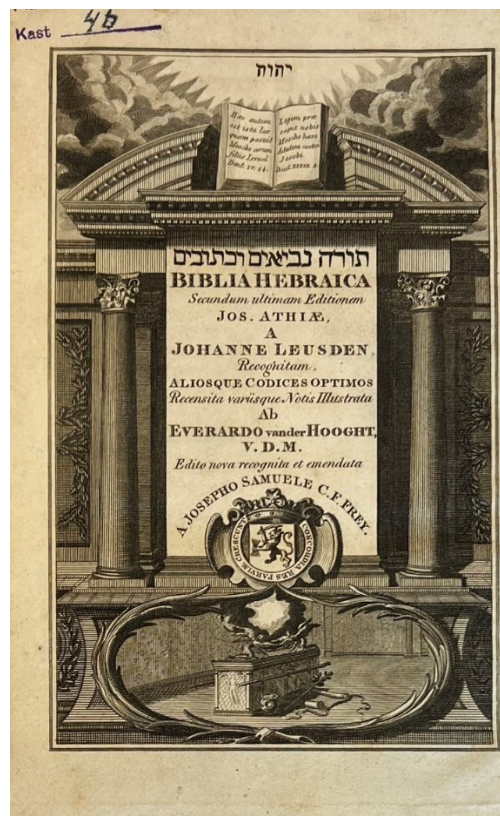

In 1589 came our second edition, in nine volumes, increased by the addition of a good many treatises, but marked also by the omission of several which had called forth the censure of the authorities. Among these were the works of Nicholas de Clemanges, whose animadversions on ecclesiastical matters had seemed to surpass the bounds of fair criticism. In 1817 he was appointed as professor at the law faculty of the new University of Leuven. King Willem I of the Netherlands had agents in Germany who looked for well-known scientists for him to staff the new state universities of Ghent, Liège and Leuven. One of them was Baron Hans Christoph Ernst von Gagern, whom Birnbaum had gotten to know. He introduced the only twenty-four-year-old as a candidate for a professorship in Leuven. He may be appointed as a reserve candidate because more important legal scholars who had been approached had refused the post. Birnbaum proved to have considerable adaptability, both in the use of languages and in the method of teaching. Here his comparative law studies that he had undertaken with Mittermaier came in extremely handy. As a result he was commissioned to draw up a new Dutch criminal code. In 1824-1825 he was rector magnificus of the university. He worked to organize exchanges of professors and students with neighboring universities. He stayed at Leuven University until 1830, when he returned to Germany to learn at the Universities of Bonn (1830), Freiburg im Breisgau (1833), Utrecht (1835) and Gießen (1840). As such it is a fine example of the achievements of the Dutch humanistic judicial tradition. One of the pieces became more known because of a quite curious controversy it aroused with Bynkershoek's colleague, professor of Law in Leiden, and friend Gerard Noodt. Bynkershoek arrives in this work at different conclusions on the relatively minor subject 'De occidendi et exponendi liberos apud veteres romanos' (the abandoning and killing of children). At that point the discussion among the former friends escalates. Noodt answers Bynkershoek in 1722 with an 'Amica Responsio' formulated, however, in a quite virulent tone. Bynkershoek replies in 1723 with the here contained 'Curae secundae', in the dedication whereoff he deplored Noodts attitude. The text of the 'Amico Responsio' is here reproduced on the upper half of the page to which Bynkershoek adds his sometimes sarcastic commentaries. 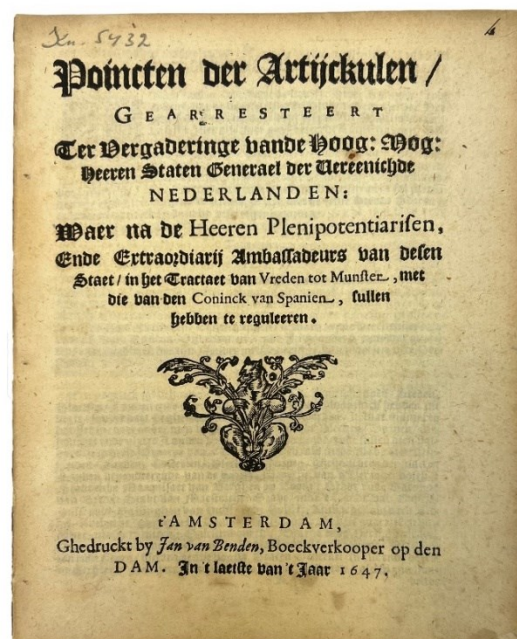

Text in latin and dutch. - In the 18th-century the publication of new journals in the Netherlands was flourishing. According to Buijnsters [1] one can distinguish popular, scientific, satirical and spectatorial journals. *De Regtsgeleerde* is a typical spectatorial journal, with moralizing, critical essays on the issues of the time and the first entirely devoted to law, legal science and legal practice in the Netherlands, with

contributions mainly in the Dutch language, and some in latin. It was published monthly from Mai 1767 untill December 1772 in 6 volumes. In his preface the author refers to the new publication of contemporary foreign law journals: *Journal de Jurisprudence* (Bouillon, 1763-); *Die juristische Bibliothek* by Selchow (Göttingen, 1764-1782) & *Recht und Unrecht* (Duisburg, 1765-). The content of *De Regtsgeleerde* consists for a large part of reviews of books, and essays on natural, roman, constitutional, criminal and private law. It also follows actual Dutch legal developments, including the deaths of important jurists, academic orations and promotions, appointments of judges, legal professors and legal civil servants. *De Regtsgeleerde* offers an unique and detailed insight in the Dutch legal world during the Enlightenment, and has been largely unexplored, with an author unknown. In the only article on *De Rechtsgeleerde* in 1987 [2] a suspicion was formulated that Elie Luzac, publisher & printer in Leiden, is the author of this journal, but this is rejected by Rietje van Vliet, author of a thesis on Luzac in 2005 [3]. The journal is rare, complete sets have only been located in the holdings of 4 Dutch libraries (KB, and the University libraries of Groningen, Leiden & Utrecht), and 2 incomplete sets (University of Amsterdam & MPI, Frankfurt am Main). 1. In het Voor-bericht vraagt hij zijn lezers bijdragen toe te sturen, de toeschrijving aan Elie Luzac lijkt voorbarig en onjuist. Het Voor-bericht, oorspronkelijk geschreven als een prospectus, begint met een dichtstuk in het Latijn en het Nederlands, waarin de auteur verklaart zich verre te houden van schimpen en schelden. Er gebeurt echter zo veel wat niet geoorloofd is, dat hij uitroept: 'Wie krygt zelfs op straat geen lust om heele Vellen / te schryven?' Men wordt daardoor tegen wil en dank een 'heek'laar in dees tyd' Daarna wordt het Voor-bericht in proza vervolgd. De schrijver 'zal over de misbruiken van aller derzelve oeffeningen [van de rechtsgeleerden] byzonder handelen'. In de eerste aflevering introduceert hij dan ook, als waarschuwing aan het adres van rechtenstudenten, twee bijna archetypisch foute rechtsgeleerden: de jurist als flierefluiter ('Jan van Lichten') en de jurist die zijn vak niet bijhoudt omdat hij de titel behaald heeft om een goed huwelijk te kunnen sluiten ('Piet Voor Zig Heen'). Het honorarium van advocaten en de bejegening van klanten zijn ook onderwerpen waar de Regtsgeleerde aandacht aan besteedt. Verder zal de schrijver over rechtbanken alleen*

in algemene bewoordingen spreken. Kerkelijke en militaire rechtbanken komen slechts ter sprake wanneer zij met gewone rechtbanken van doen hebben. Van het 'Staatsbestier' wenst hij zich verre te houden, dat wil zeggen: alleen naar aanleiding van een boek of een ingezonden brief. Het blad zal de volgende inhoud hebben. Allereerst staan er besprekingen in van rechtsgeleerde studies, disputaties en andere redevoeringen die in de Republiek zijn verschenen en/of in het Nederlands vertaald zijn. Vandaar dat er relatief veel aandacht is voor de relatie Romeins Recht en natuurrecht, en voor de in de ogen van de Regtsgeleerde verwerpelijke ideeën van de Groninger hoogleraar Van der Marck. Ook de *ars critica* - de Regtsgeleerde vindt dat juridisch filologen de rechtspraak niet uit het oog mogen verliezen - en strafrechtelijke thema's komen in de recensies aan de orde. Andere rubrieken zijn: overlijdensberichten van bekende Nederlandse rechtsgeleerden (hoogleraren, leden van Hoven van Justitie); necrologieën van deze overledenen (alleen Herman Noordkerk, met dichtstukje van Elisabeth Wolff-Bekker); rechtsgeleerde verhandelingen (biografie Justinianus) en ingezonden brieven met een reactie daarop (onderwerpen: polygamie, militaire tucht, zedeloosheid en ongemaniërdheid van de jeugd, schriftelijk pleiten, verbergen van misdadigers). Afleveringen kunnen eventueel worden beëindigd met academienieuws (vooral in deel 4) en letternieuws (boek aankondigingen; zie echter het Naricht in deel 6 over kritiek van de uitgever over dit onderdeel en het kleine korps dat voortaan voor dit nieuws zal worden gebruikt). Nadrukkelijk stelt de auteur dat hij zijn stijl 'niet als een Grammaticus [heeft] ingerigt'. Hij gebruikt de woorden die ook in de rechtshoven worden gebruikt, of het nu bastaardwoorden zijn of niet. In het Voorbericht stelt de auteur dat de 'Kerkelyken' hun Zeedemeester der Kerkelyken (1750-1752) hebben, geneeskundigen hebben hun Artz, of Genees-Heer (1765-1771), maar juristen hebben niets. Hoog tijd dus dat er nu een vergelijkbaar blad komt voor 'heele en halve Regtsgeleerden': voor procureurs, advocaten en solliciteurs. De Regtsgeleerde schaart zich hiermee in de traditie van deze zede-meesters. Voor zover bekend werd het blad niet besproken in eigentijdse media, zoals de *Vaderlandsche Letteroefeningen*. In 1809 verscheen van de hand van Seerp Gratama, in diens *Regtsgeleerd Magazijn*, een korte signalering. De *Thalia* werd uitgegeven door Johannes van den Bergh, die verder alle bij het leven van Focquenbroch verschenen werken verzorgde. De titel van deze bundel kan men als programmatisch beschouwen: *Thalia* is de muze van de komedie en 'geurige', dat wil zeggen geestige, dichtkunst. Hij bevat een burlesk episch gedicht bruiloftsdichten, gedichten die een geschenk begeleidden, burleske en petrarcaanse lyriek, overpeinzingen, puntdichten, (rijm)brieven en liedjes, zowel in het Nederlands als in het Frans. De liedjes zijn contrafacteren: nieuwe teksten op bekende melodieën. Die melodie werd door middel van haar benaming of de eerste regel van een bekende tekst op die melodie aangegeven. De latere *Thalia's* hebben een soortgelijke inhoud. In 1665 viel de bisschop van Münster de Republiek binnen. Ter gelegenheid hiervan verscheen het pamflet *Den Munstersche trommel-slagh*, op den Hollandschen toon, waarin wordt gesteld dat de Hollandse ketters nu eens flink aangepakt zullen worden. Hierop reageerde Focquenbroch met *Een Hollandsche vuyst-slagh*, op een Brabandsche koon. Zo was ook het verslaan van de Engelse vloot in 1666 voor Focquenbroch en zijn vriend Johannes Ulaeus aanleiding om een *Verdubbelt zegen-sangh*, der negen musen te schrijven. Ulaeus bezingt hierin de dapperheid van de Hollanders en Focquenbroch maakt met behulp van dezelfde rijmwoorden de Engelsen belachelijk. Johannes Ulaeus werkte ook mee aan een vertaling c.q. bewerking van Vergilius' *Eclogae* die onder de titel *De herders-sangen van Virgilius Maro* in 1666 verscheen. Wederom nam Ulaeus het serieuze deel voor zijn rekening. Hij maakte een gewone vertaling, terwijl Focquenbroch de zangen in burleske stijl bewerkte. Op 7 augustus 1668 kwam een nieuwe bundel uit, *Thalia*, of geurige zang-goddin, tweede deel, even later gevolgd door een herdruk van de eerste (op 25 augustus). In deze tweede bundel zijn de *Munstersche trommelslagh* en de *Hollandsche vuyst-slagh* opgenomen en tevens Focquenbrochs aandeel in het *Verdubbelt zegen-sangh*. In april 1674 verscheen postuum het blijspel *Min in't lazarus-huys*, een bewerking van Lope de Vega's *Los locos de Valencia*. De tekst moet al eerder in Amsterdam gecirculeerd hebben, want hij kwam op 10 december 1669 ter tafel

tijdens een bijeenkomst van het letterkundig genootschap 'Nil Volentibus Arduum'. De derde en laatste bundel van Focquenbroch werd in 1678 uitgegeven, namelijk de Afrikaanse Thalia, Of het derde deel van de geurige zang-godin. His teachers included Manoel da Costa, Arias Pinhel and Padilla Meneses. He became a judge at the Provincial Court in Galicia, later at the Royal Court and Senate of Castile in Madrid and finally Royal Fiscal in Valladolid. The *De expensis et meliorationibus Commentarius* is one of the most

widespread and longest-circulated works of public law literature in Europe. It was first published in Alcalá de los Henares (Complutum) 1578. Reprints occurred in Antwerp 1586, Lyon 1589, Valladolid 1592, Alcalá 1597, Cologne 1599, Marburg 1601 and 1614, Antwerp 1614, Madrid 1622, Amsterdam 1646, 1651, 1655, 1656, 1666 and 1668, Lyon 1671 and Cologne 1692, 1709, 1711 and 1737. It deals with the obligation to pay or to compensate for benefits that the recipient ultimately does not deserve (uses made by the bona fide owner on the property to be handed over to the owner, advance receipts from a co-heir, maintenance payments by a third party instead of the maintenance debtor, etc.). The legal basis is not only common, but also Castilian territorial law (Leyes de Toro). Strictly speaking, therefore, it is not a comment; it does not explain a specific law, but describes a subject area, a tract. Educated at Paris University, he came under the influence of Isaac Scaliger, -who directed his attention towards the obscurer fathers of the Church. In 1603 he was appointed to a lectureship at the university of Bourges, but resigned his place two years later, in order to enter the Society of Jesus. For many years he was professor of divinity at the College de Clermont, the chief Jesuit establishment in Paris; At sixty years of age he stopped teaching, but retained his office of librarian and consecrated the rest of his life to his great work, the "Dogmata theologica". He was one of the most brilliant scholars in a learned age. Numerous eulogies were pronounced on him by his contemporaries, such as Huet, Valois, Grotius, Isaac Voss, F. Clericus, Noris, etc. Carrying on and improving the chronological labors of Scaliger, Petau published in 1627 an *Opus de doctrina temporum*, which has been often reprinted. But Petaus eminence chiefly rests on his vast *De theologicis dogmatibus*. In 1643 the first three volumes were published (dated 1644); the fourth and fifth volumes were published in 1650. The work was incomplete at the death of the author, and, despite several attempts, was never continued. Various editions have been published, including that by the Calvinist Jean Le Clerc in Antwerp (Amsterdam) 1700; In 1757 F. A. Zaccaria S.J. republished the work in Venice with notes, dissertations, etc.; Zaccaria (1714-1795) was a.o. professor of church history at the Sapienza and director of the *Accademia de' Nobili Ecclesiastici*. He was a member of at least nineteen Italian academies. In 1857 Passaglia and Schrader undertook a similar work, but they produced only the first volume. 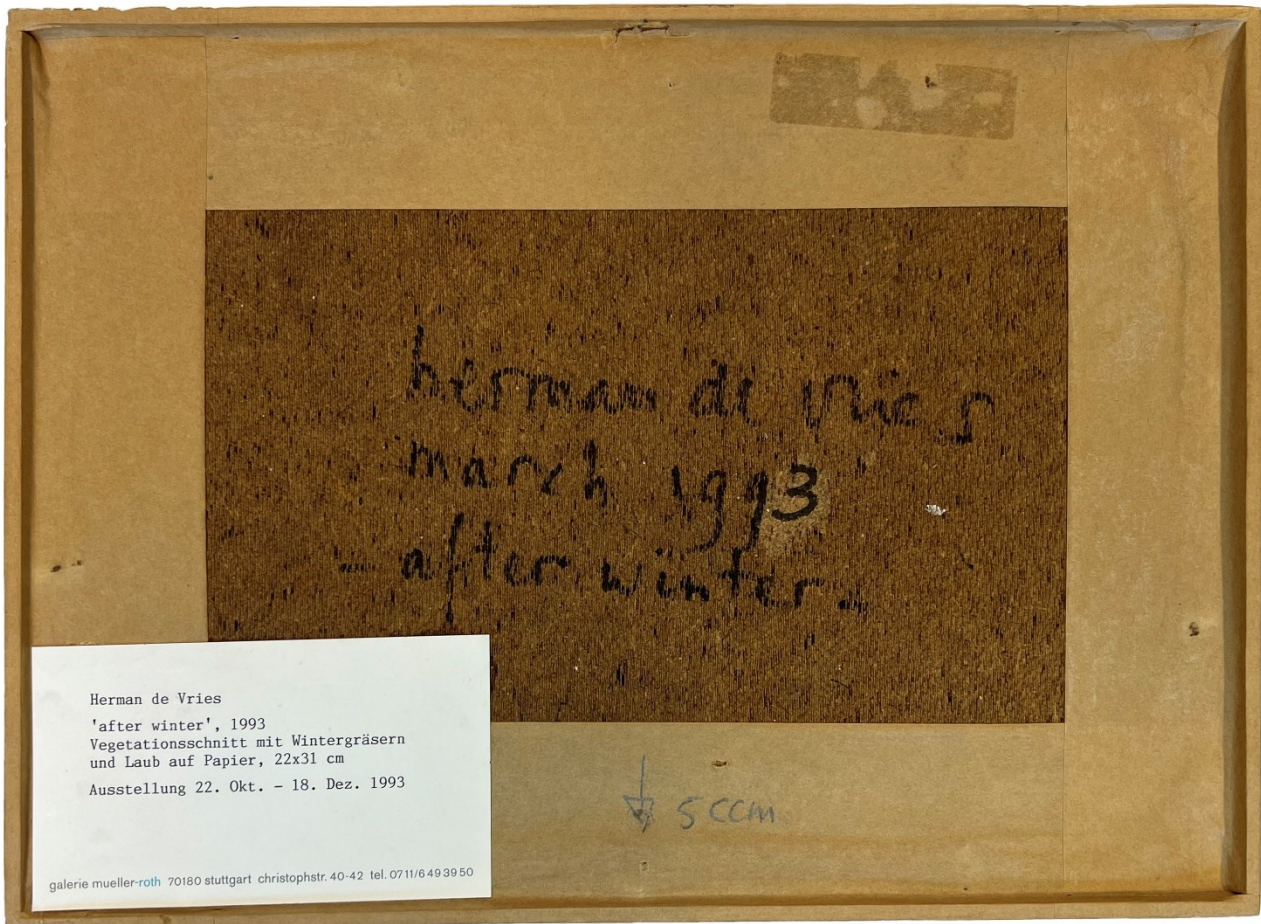
