FIRST and ONLY EDITION—A COMPLETE RUN. Published from March/April 1945 to October 1946 in five numbers, edited by Carlos Dias Ferreira and Carlos Gouveia Pinto, *Aqui e Além* was graphically indebted to José Espinho and published by Felipe S. Rodrigues. A periodical of University students, it aimed to be free of ideological dogmatism, and did not belong to any single literary movement. A section of literary criticism was written by David Mourão-Ferreira, João Rosas and Joel Serrão. Art criticism was the province of Alberto Correia, music Joly Braga Santos and theater Luiz Francisco Rebello.

The review included one of the earliest texts by Mário Cesariny (signed Mário de Vasconcelos, "Notas sobre o Neo-Realismo Português, in numbers 3 and 4), a text by António Sérgio ("Explicação e Subsunção sob Fórmulas Gerais"), David Mourão-Ferreira ("Notas sobre Fernando Pessoa" and "André Gide e o Esistencialismo"), Jacinto Prado Coelho ("Originalidade e Lugar Comum" and "Rodrigo Lobo Poeta Bucólico"), a poem by José Régio ("Obsessão"), poems by Luiz Francisco Rebello and his important essay ("O Sentido Trágico na Obra Teatral de Federico García Lorca" in numbers 4 and 5), an interview with José Régio by Maria Adelaide Correia, and a poem by Vitorino Nemésio ("Silêncio é Peso de Deus"). There are also texts by Cabral de Nascimento, Evelyn Waugh, José Régio, Maria de Lurdes Belchior, Natércia Freire, Pedro Homem de Mello, Manuel de Lima, Stephan Leacock, Victor Palla, and numerous others. There are also reproductions of water colors, oil paintings, designs and sculptures by António Sampaio, Barata Feio, Bonifácio Lázaro, Cândido Costa Pinto, Carlos Carneiro, Carlos Ribeiro, Diego Rivera, Francisco Rodrigues, Jorge de Oliveira, José Espinho, Juan de Alvaros, Júlio Santos, Manuel Ribeiro, Maria Keil do Amaral, Ramon Rogent, Ricardo Hogan and Rodin.

NOTAS SOBRE FERNANDO PESSOA

O «CASO» DE ALBERTO CAEIRO

Alberto Caeiro, encarado sob um ponto de vista estético — ou melhor: sob um ponto de vista formal —, é um poeta medíocre. Não é necessário encobri-lo, porque tal afirmação não ensombra de maneira nenhuma o indiscutível valor de Fernando Pessoa.

De resto, Fernando Pessoa não desejou fazer dele um artista. Quis apenas criar um poeta, em que existia simplesmente o desejo, natural e espontâneo, de contar «a espantosa realidade das coisas». Por isso, não é legítimo que se vá criticar, nos poemas de Alberto Caeiro, a ausência daqueles valores estéticos que o próprio Pessoa desejou que estivessem ausentes. Eça de Queiroz, numa carta a Mariano Pina sobre a crítica que Fialho de Almeida fizera a «Os Maias», diz: «Criticar o livro como ele faz, não pelo que é mas pelo que devia ser, é ridículo». Seria também ridículo ir criticar os poemas de Caeiro não pelo que são, mas pelo que deviam ser.

Contar «a espantosa realidade das coisas» é, como já se disse, o desejo de Alberto Caeiro. Fiel a esta orientação, o poeta de «O Guardador de Rebanhos» condena tudo o que, de qualquer forma, possa adulterar essa realidade. Quanto a ele, há dois factores que especialmente contribuem para isso: certa imagística poética e a atribuição de falsas significações aos objectos e fenómenos da Natureza. Logo aqui, Alberto Caeiro se revela um poeta totalmente oposto ao sentido geral do lirismo português. Assim, Alberto Caeiro diz as coisas o mais objectivamente possível, sem recorrer a imagens, símbolos ou quaisquer outros processos artísticos, que desvirtuariam a ideia, ou antes a expressão da sensação recebida (¹):

FIRST and ONLY EDITION. Well-researched historical account of the life of those incarcerated by the Inquisition in Portugal. Includes accounts of what prisoners ate, how they occupied their time, and hygiene. Of the many illuminating tables, one includes the instructions for torture on the rack in comparison to the instructions for torture by strappado (polé, [p. 80]); another lists the names of children born to women while imprisoned by the Inquisition (pp. 137-8).

First and Only Edition in English. Gonzalo Fernández de Oviedo y Valdés, (1478-1557), warden of the fortress and port of Santo Domingo of the Island of Hispaniola, also served his emperor, Charles V, as the official chronicler of the first half-century of the Spanish presence in the New World. His monumental General y Natural Historia de las Indias, consisting of three parts, with fifty books, hundreds of chapters and thousands of pages, is still a major primary source for researchers of the period 1492-1548. Part One, consisting of 19 books, was first published in 1535, then reprinted and augmented in 1547, with a third edition, including Book XX, the first book of Part II, appearing in Valladolid in 1557. Book XX, which was printed separately in Valladolid in 1557 (the year of Oviedo's death), concerns the first three Spanish voyages to the East Indies. While it might be expected that the narrative of Magellan's voyage would predominate in Book XX, Oviedo devoted only the first four chapters to this monumental voyage. The remaining thirty-one concern the two subsequent and little-known Spanish follow-up expeditions to the Moluccas 1525-35. The first, initially led by García Jofre de Loaysa, set out from Coruña to follow Magellan's route through the Strait and across the Pacific. A second relief expedition under Alvaro Saavedra was sent out in search of Loaysa's company from the Pacific coast of New Spain in 1527. In each venture only one vessel reached the Spice Islands. Oviedo's narrative offers many details of the 10 years of hardships and conflict with the Portuguese, endured by the stoic Spanish, and of the growing unrest it provoked among their indigenous hosts. The news that Charles V had pawned his claim to the King João III of Portugal allowed a very few of the Spaniards to negotiate a passage back to Spain via Lisbon, while others remained in Portuguese settlements in the East Indies. The reports made by the returnees to the Consejo de Indias were integrated by Oviedo into his narrative, expanded and enriched by personal interviews. His chronicle includes much information about the indigenous culture, commerce, geography and of the exotic fauna and flora of the Spice Islands. Professor Dille's translation of portions of Book XX in this present volume, provide welcome access to some of the treasures of a huge text which is still largely available only to readers of Spanish.

FIRST and ONLY EDITION of this significant, previously unpublished work by Antonio Gouvea (Casale, Viseu, 1592-Fou-Tcheou, 1677), a Jesuit missionary who worked in China for 36 years and was a captive in Canton for 6 of them. The original manuscript, written in China and dated 1644, is in the library of the Palácio de Ajuda. The introduction, heavily annotated, occupies pp. 19-165 of volume I. The introduction to volume II occupies pp. [9]-11. The introduction to volume III occupies pp. [9]-12. A brief introduction to volume IV by Filipe Araújo occupies pp. [9-10] and is dated 3 April 1918. Horácio P. Araújo has provided the notes to volume IV.


Either the FIRST EDITION, later issue, or second edition, later issue of this rare type specimen book.

The many bold annotations are said to have been made by the Director of the Imprensa Nacional, whose copy the present book is supposed to have been, though this has not been substantiated. Dates in 1929 are often written for numerous types which are declared "Inutilizado" and stamped "CONFERIDO".



We speculate that the irregular pagination may be due to additions and deletions made between the publication date of 1915 and 1929, the date of many of the annotations.

Beyond examples of type, the book includes many examples of illustrations. To name one instance, there is a full page illustrating the United States Centennial Commission medal, in different sizes (p. 330); there is also a page with several examples of the coat of arms of the British Monarchy, in addition to a few illustrations of the coat of arms of the French Republic (p. 241).



FIRST EDITION, rare, and the only one printed in Portugal of a most influential work on Roman law which was reprinted many times in various places in Europe during the sixteenth century and early seventeenth century.

The author's dedication to the Cardinal-Prince D. Henrique occupies the second preliminary leaf recto. At the end on leaf Y2 recto is a letter to the readers by Innocêncio Soeiro, a disciple of the author. Soeiro also compiled the indexes that follow.

Aires Pinhel (Coimbra, 1512-Salamanca, 1562?), received his bachelor's degree at the University of Salamanca, where he was one of its most distinctive students. He then earned a doctorate in Roman Law from Coimbra University. Chosen by D. João III for a leadership role at Coimbra in 1556, he was simultaneously made a desembargador da Casa da Suplicação. Three years later he returned to Salamanca to assume an important position at the University there.

António de Maris, along with João de Barreira and Germão Galharde, was one of the three most prolific printers to work in Portugal during the sixteenth century. He began in 1556, making this one of his earlier productions. Printing in Coimbra from 1556 to 1599, he also worked occasionally in Braga and Leiria.

Provenance: José António de Souza, unidentified seventeenth-century [?] owner. Lopes Praça appears to have been José Joaquim Lopes Praça (1844-1920), important jurist who dedicated himself to education, professor at the Faculty of Law at Coimbra University, author in 1868 of História da Filosofia em Portugal nas suas relações com o movimento geral da filosofia. He also wrote Ensaio sobre o padroado Português (1869), A Mulher e a vida ou a Mulher Considerado debaixo dos seus Principais Aspectos (1872), Direito Constitucional Português: Estudos sobre a carta constitucional de 1826 e acto Constitucional de 1832 (3 volumes, 1878-1880),



Sousa Viterbo (Porto, 1845 or 1846-Lisbon, 1910), physician, journalist, historian, archeologist and poet, received his medical degree in 1776, was a naval doctor, but soon became more interested in the humanities, becoming a professor at the Escola de Belas-Artes. Among the more important works of this prolific author were *Dicionário histórico e documental dos arquitectos, engenheiros e constutores portugueses*, 3 volumes, 1899-1922; *A livraria de música de D.João IV e o seu índice. Notícia histórica e documental*, 1900; *O movimento tipográfico em Portugal no século XVI. Apontamentos para a sua história*, 1924; *Noticia de alguns pintores portuguezes e de outros que, sendo estrangeiros, exerceram a sua arte em Portugal*, 1911; *A litteratura hespanhola em Portugal*, 1915.

Provenance: Boaventura da Fonseca e Silva de Viterbo (1831-1896) was the author's uncle. He was the father of Fiel da Fonseca Viterbo (1873-1954).







NOTAS SOBRE O NEO-REALISMO PORTUGUÊS

(Conclusão do número anterior


Muitos terão em dúvida que se possa, desde já, falar de um neo-realismo português. Outros afirmarão, talvez, que êle é um facto incontestável, patente, todos os dias, nos quadros da nova literatura. Uns e outros podem ter razão... consoante as razões com que provarem o seu aplause ou a sua desconfiança. Resumindo — talvez demais... — os dados do problema, consiste êle em que o neo-realismo é um facto, no que respeita ao ponto de vista crítico do escritor, a certas conquistas técnicas, e, principalmente, nos acontecimentos sociais que lhe deram origem; enquanto que em realizações (expressão, estilo. planificação das obras), parece não ter atingido ainda aquele estado de plenitude que no Brasil, por exemplo, já nos deu umas «Vidas Secas», de G. Ramos, quanto a nós, uma autêntica obra-prima do neo-realismo brasileiro.

Assim, os que tudo vêem através de «postulados estéticos», «escolas literárias», «movimentos artísticos», etc., ainda não acharam que valesse pena considerar que o neo-realismo português, tal como hoje se encontra, é fortemente representativo de certos acontecimentos que acabarão por assaltar

toda a espécie de estilos, escolas e movimentos artísticos.

Assim, vemos, por vezes, menoscuidar-se uma forma que nem por ser interpretativa desses acontecimentos sociais, pode deixar de ser forma. Na poesia, no romance — os pintores começaram a aparecer —, apesar dum Alvaro Feijó, reina uma certa arbitrariedade. Não nos refeririamos a ela se fôsse tão sòmente resultante da personalidade própria de cada escritor, do seu estilo, da sua técnica. Um reparo assim orientado trairia qualquer coisa tão nefasta como o desejo de um padrão único para as obras do neo-realismo literário. Arbitrariedade vêmo-la, sim, no uso de certas formas menos recomendáveis, na exploração de certos estados psicológicos de que
