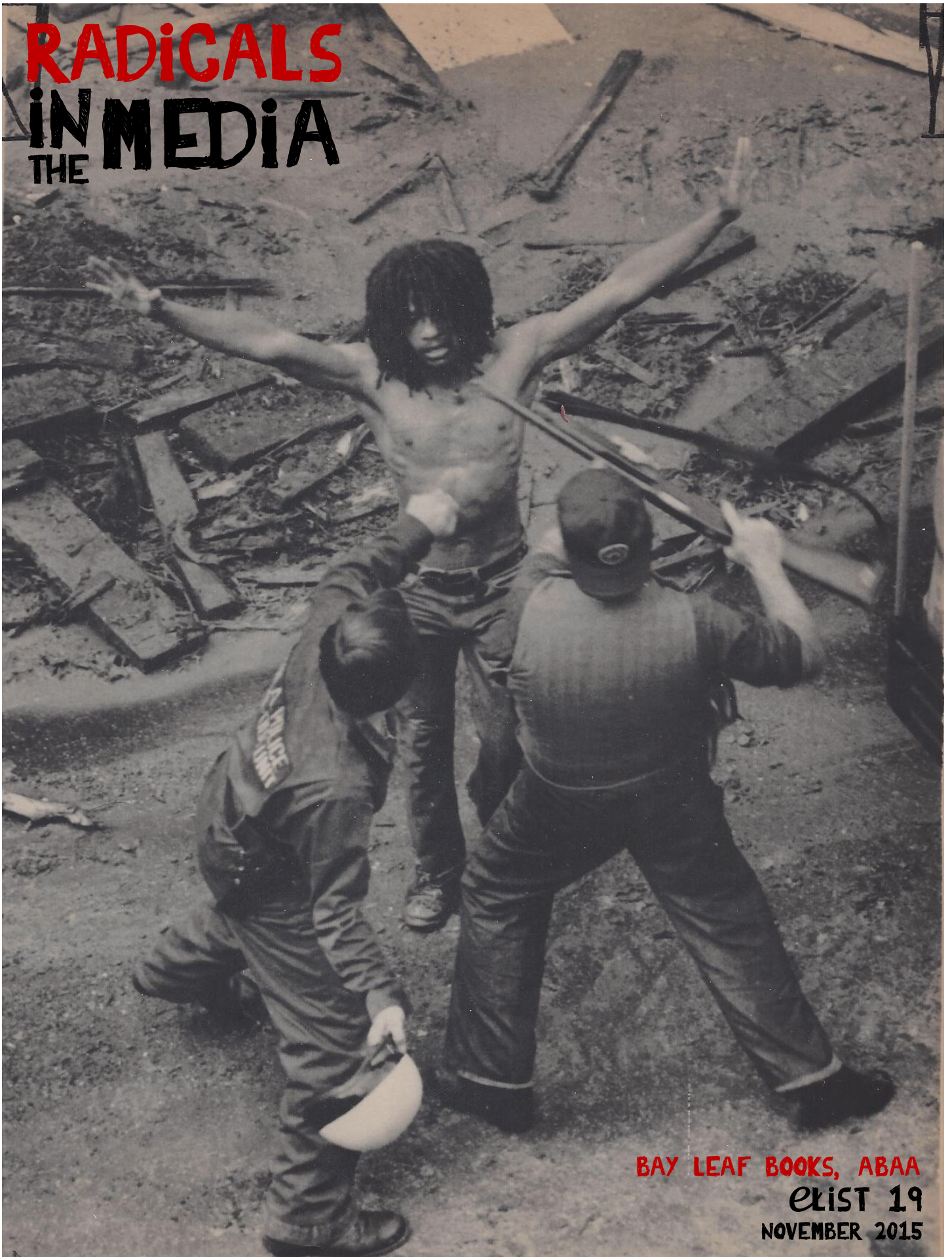

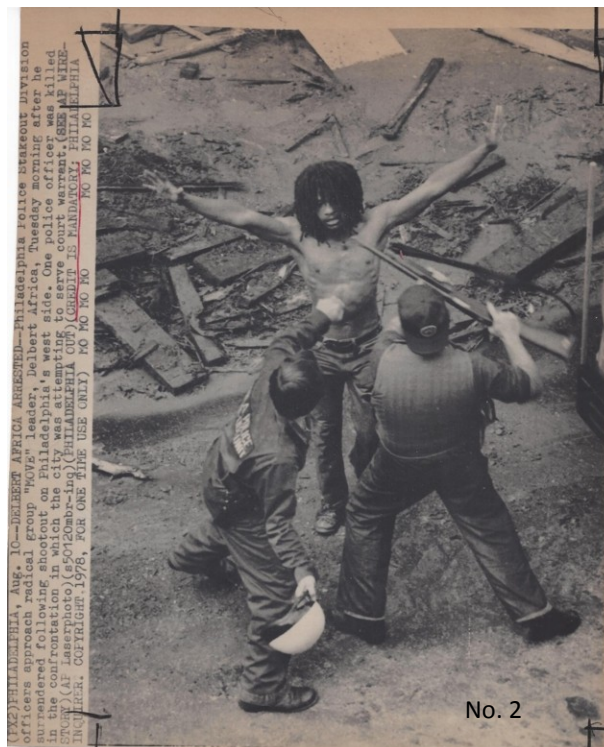
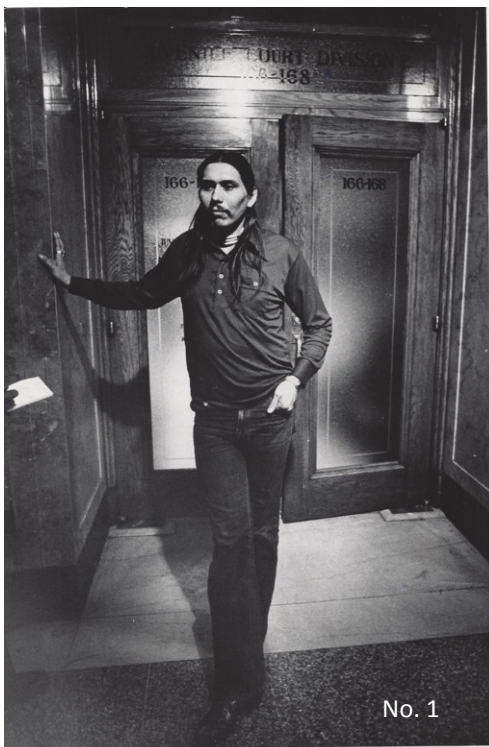

Press photos are interesting objects. While they are almost always copies, or copies of copies, they can sometimes be the only extant print of an image whose original has been lost to time. For collectors they are an inexpensive way to own a piece of history; and for researchers, the sometimes extensive captions, news clippings and date stamps are essential clues in piecing together history. This selection of press images focuses on radicals, including visionaries, trouble-makers, and problem-children. Below you'll find the Black Panthers, SLA, and AIM, as well as Socialists, Communists, and anarchists. Enjoy...

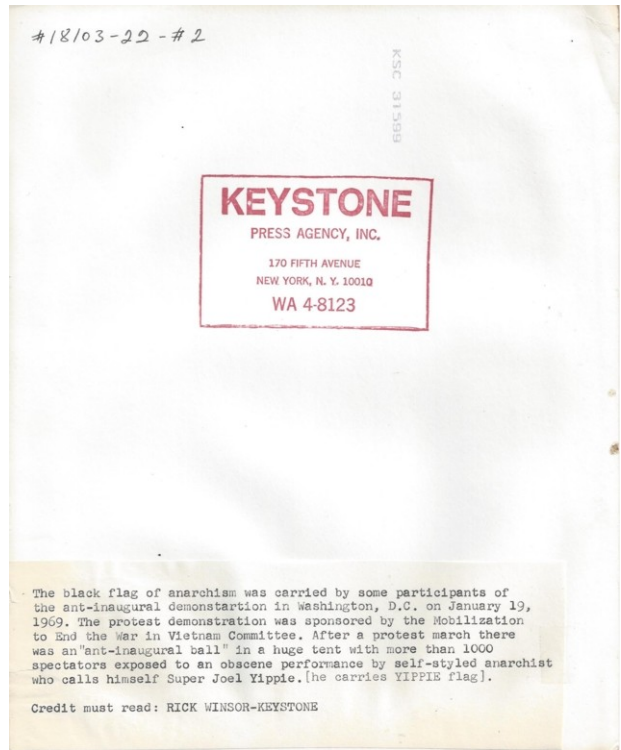
### Some Notes on our Descriptions

Since many press images are trimmed by hand, the edges are often uneven and therefore measurements are approximate. "Touch-ups" refer to the pre-photoshop days of using white, black and grey paints to help define the images; common touch-ups include defining lips or hairline, texturing clothes, or blurring the background so the subjects stand out more. Finally, while there is debate about press image terminology, we use "press photo" to refer to an image that, in all probability, was printed from a negative – including film negatives, glass negatives, or taking a photograph of another photograph. We use "wire photo" in reference to images, often with attached captions, that were transmitted via telegraph or telephone wires (a practice that began in the 1920s).

1. **[American Indian Movement] Press Photo of Carter Camp, AIM Activist.** Denver: Denver Post, photo by Dave Buresh, January 17, 1974. Press photo, 16.3 by 25 cm. Very good with agency stamps and pencil notes on verso. A wonderful image of Carter Camp (1941-2013), an AIM activist that was heavily involved in the 1972 Trail of Broken Treaties protest and the 1973 Wounded Knee occupation. In late years Camp was actively opposed to the Keystone Pipeline. \$50.00



2. **[Anarchist, Black Liberation, MOVE] Wire Photo, Delbert Africa Arrested.** Philadelphia: Philadelphia Enquirer, August 10, 1978. Wire photo, 19.7 by 24.3 cm. Very good with wax pencil crop marks on the image; pen and pencil notes and a spot of skinning from a removed label on verso. A truly striking image of Delbert Africa, a leader of the communal MOVE activist group. After the 1978 shootout, in which a police officer was killed, nine MOVE members were sentenced to 100 years in prison, including Delbert Africa. The caption reads: "PHILADELPHIA, Aug. 10 -- DELBERT AFRICA ARRESTED -- Philadelphia Police Stakeout Division officers approach radical group 'MOVE' leader, Delbert Africa, Tuesday morning after he surrendered following shootout on Philadelphia's west side. One police officer was killed in the confrontation in which the city was attempting to serve court [eviction] warrant." MOVE remains active today. See detail on the cover of this list. \$85.00

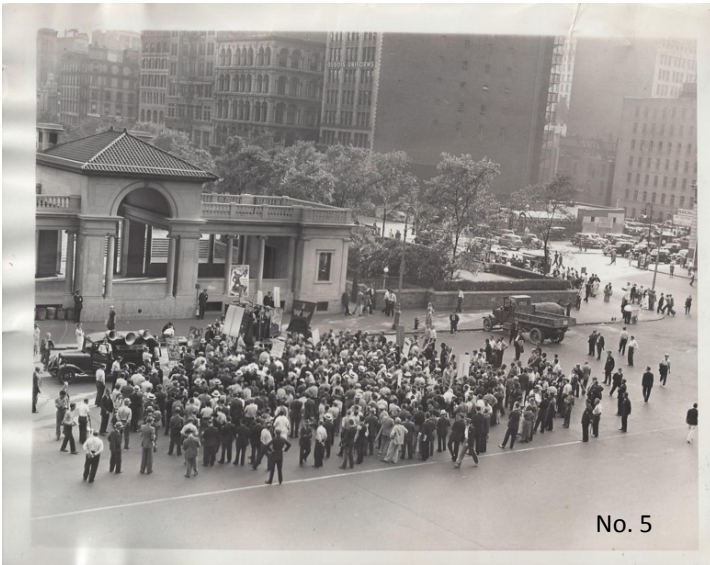


3. [Anarchist, Vietnam Protest] "Anti-Inaugural Ball" Press Photo. New York: Keystone Press Agency, January 19, 1969. Press photo, 20.5 by 25.3 cm. Very good with caption and agency stamp on verso. Caption reads: "The black flag of anarchism was carried by some participants of the anti-inaugural demonstration in Washington, D.C. on January 19, 1969. The protest demonstration was sponsored by the Mobilization to End the War in Vietnam Committee. After a protest march there was an "anti-inaugural ball" in a huge tent with more than 1000 spectators exposed to an obscene performance by self-styled anarchist who calls himself Super Joel Yippie (he carries YIPPIE flag)." \$26.00



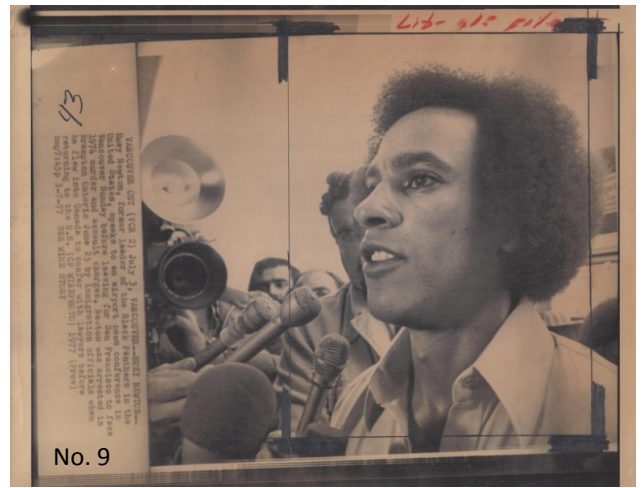
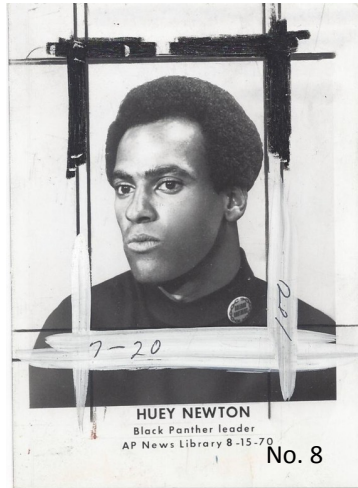
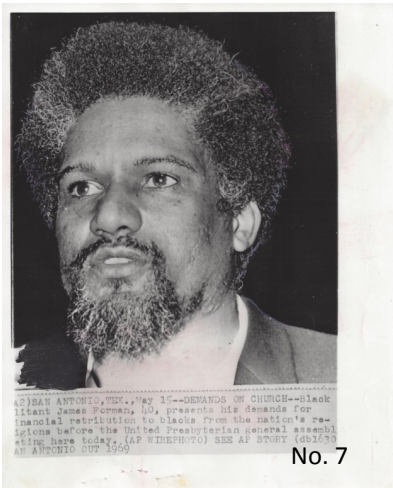
4. [Anarchist, Vietnam Protest] Press Photo of London Anarchists Protesting the Vietnam War. London: Europix/United Press International, March 25, 1968. Press photo, 25.8 by 20.5 cm. Very good with agency stamps and caption on verso. A wonderful image with protestors sporting Kilburn Anarchists and Young Communist League banners, and signs that read "Stop America's Brutal War on Vietnam," "Condemn the Bombing of Civilians," and "Dissociate." The caption reads: "LONDON: Banners from anarchists, Communists and all sorts of protest groups wave over this mass of people wedged into London's Whitehall... street of government offices and Ministries. The crowd marched through central London demonstrating disapproval at the Vietnam war. Actress Vanessa Redgrave handed letters of protest into the Premier's residence, at 10, Downing St." \$35.00

5. **[Anarchist, I.W.W.] Press Photo of 1937 Anarchist Rally in Union Square.** New York: Acme Newspictures (Newspaper Enterprise Association), July 26, 1937. Press photo, 22.9 by 18 cm. Very good with agency stamps on verso and some rippling due to the caption that is affixed to the back. The caption reads: "At anarchist rally at Union Square." I.W.W. banners can be clearly seen. \$50.00



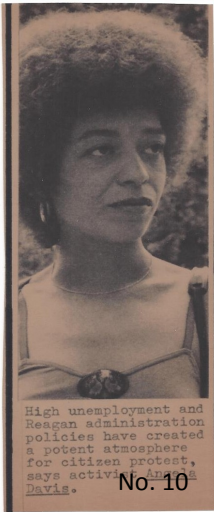
6. **[Anarchist, Sacco-Vanzetti] Press Photo of the Sacco-Vanzetti Funeral in Boston.** New York: Acme Newspictures (Newspaper Enterprise Association), May 20, 1930. Press photo, 25.3 by 20.4 cm. Very good with agency stamps and caption on verso. The caption reads: "Under heavy police guard the funeral of the late anarchists was held. PHOTO SHOWS – the defense committee marching behind the slow moving hearses, which they did for a part of the way, till picked up by waiting autos, which whisked them to the cemetery, where the bodies were cremated." A haunting photo . \$90.00

7. **[Black Panthers, SNCC] Wire Photo of James Forman.** NP: Associated Press, May 15, 1969. Wire photo, 20.5 by 25.3 cm. Very good with a few staple holes in the bottom margin and date stamps and taped headline on verso. Forman (1928-2005) was a member of the Student Nonviolent Coordinating Committee, the Black Panthers, and Detroit's Black Economic Development Conference, for which he authored the "Black Manifesto" that, in part, demanded reparations from white churches for injustices suffered by African Americans. The caption reads: "SAN ANTONIO, TEX., May 15 -- DEMANDS ON CHURCH -- Black militant James Forman, 40, presents his demands for financial retribution to blacks from the nation's religions before the United Presbyterian general assembly meeting here today." \$25.00



8. **[Black Panthers] Wire Photo of Huey Newton, 1970.** NP: Associated Press, August 15, 1970. Wire photo, 9 by 12.3 cm. Very good with cropping; pen notes and date stamps on verso. A strong image of Newton, if heavily cropped. A "Soledad Brothers" pin can be seen on his collar. The caption simply states "Huey Newton / Black Panther leader." \$30.00

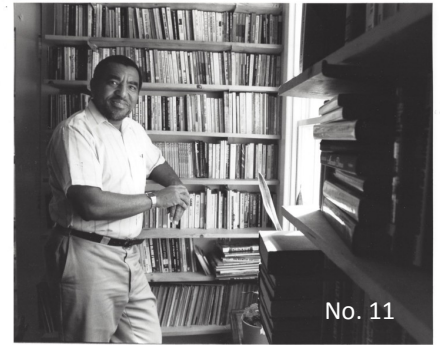
9. **[Black Panthers] Wire Photo of Huey Newton, 1977.** NP: Canadian Press, July 3, 1977. Wire photo, 21.5 by 28 cm. Very good with crop marks; date stamps and pen notes on verso. Caption reads: "VANCOUVER -- HUEY NEWTON -- Huey Newton, former leader of the Black Panthers in the United States, speaks to an airport news conference in Vancouver Sunday before leaving for San



Francisco to face 1974 murder and assault charges. Newton was arrested in Brampton, Ontario June 25 by immigration officials when he flew into Canada to confer with lawyers before returning to the U.S.” \$30.00

10. **[Black Panthers] Wire Photo of Angela Davis.** From the archives of The Morning Call (Allentown, Pennsylvania), though the image has no date or publishing information. Wire photo, 5.6 by 13.4 cm. Very good with “other” stamp and partially peeled-off label on verso. Caption reads: “High unemployment and Reagan administration policies have created a potent atmosphere for citizen protest, says activist Angela Davis.” \$10.00

11. **[Black Panthers] Press Photo of Paul Coates.** NP: No publisher, June 23, 1992. Press photo, 25.3 by 20.3 cm. Very good with caption and date stamps on verso. W. Paul Coates is a publisher who founded Black Classic Press in 1978 in Baltimore, the mission of which is to publish obscure and important books by and about people of African descent. Coates is the father of author and journalist Ta-Nehisi Coates. The caption reads: “June 23, 1992 / Photos by Lloyd Fox / People profile of Paul Coates in his home at 3700 Campfield Rd., off of Liberty Rd. He runs Black Classic Press and once headed the state’s Black Panther organization.” \$40.00



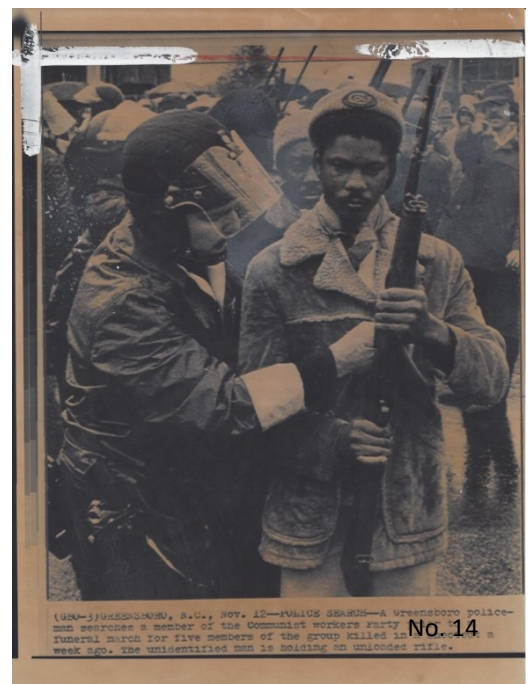
12. **[Book Shop, Chicago] Press Photo, Leftist Bookshop’s Window Smashed.** NP: Acme Newspictures, August 11, 1950. Press photo, 22.7 by 18 cm. Very good with agency and date stamps and caption on verso. The caption reads: “CHICAGO: Windows of the leftist



Community Book Store, where Socialist Eugene Debs is said to have held meetings, have been smashed five times during the past week by what a window sign terms ‘storm troopers.’ Curious passersby are shown looking in the window, which is cracked and held together by boards.” You can see a “Peace” poster dangling in the broken glass. \$40.00

13. **[Communist] Press Photo of 1934 New York Communist Demonstration.** New York: Culver Pictures, Inc., May 1, 1934. Press photo, 25.8 by 20.4 cm. Very good with corner creases and pencil notes and agency stamps on verso. An image of marchers during a May Day parade in Union Square, New York. Anti-fascist and higher wage signs can be seen, as well as large banners for the Russian National Mutual Aid Society of America. \$30.00

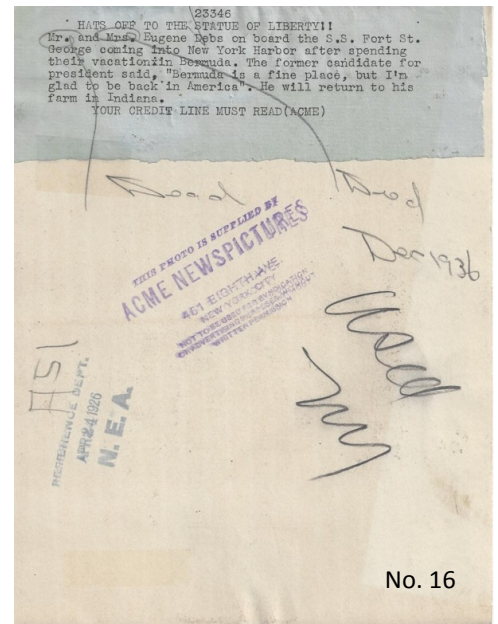
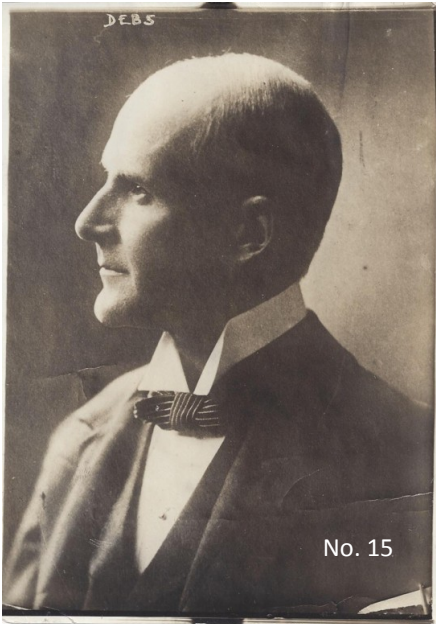
14. **[Communist Workers Party, Ku Klux Klan] Wire Photo of Greensboro Massacre Funeral March.** NP: Baltimore Sun archives, November 12, 1979. Wire photo, 21 by 27.8 cm. Very good with touch-ups, barcode and labels on verso. Printed on glossy thermal paper that has browned. The caption reads: “GREENSBORO, N.C., Nov. 12 – POLICE SEARCH – A Greensboro policeman search-



(UPI)—GREENSBORO, N.C., Nov. 12—POLICE SEARCH—A Greensboro policeman searches a member of the Communist workers party funeral march for five members of the group killed in a week ago. The unidentified man is holding an unloaded rifle. No. 14

es a member of the Communist Workers Party prior to a funeral march for five members of the group killed in a shootout a week ago. The unidentified man is holding an unloaded rifle." The funeral was held in the aftermath of the "Greensboro Massacre" where five protesters were shot and killed during a "Death to the Ku Klux Klan" march organized by the CWP. Criminal trials against the Klansmen and members of the American Nazi Party led to all defendants being acquitted by all-white juries. \$20.00

15. **[Eugene Debs] Press Photo of Eugene Debs.** New York: Culver Pictures, Inc., May 8, 1920. Press photo, 12.8 by 17.8 cm. Very good with light corner wear and one small edge tear. Notes and labels on verso that cover up the original date, but 1920 can still be seen. A somewhat grainy photo of a photo of Debs (1855-1926), a founding member of the International Workers of the World and Social Democratic party of the United States, and five-time presidential candidate on the Socialist party of America ticket. \$30.00



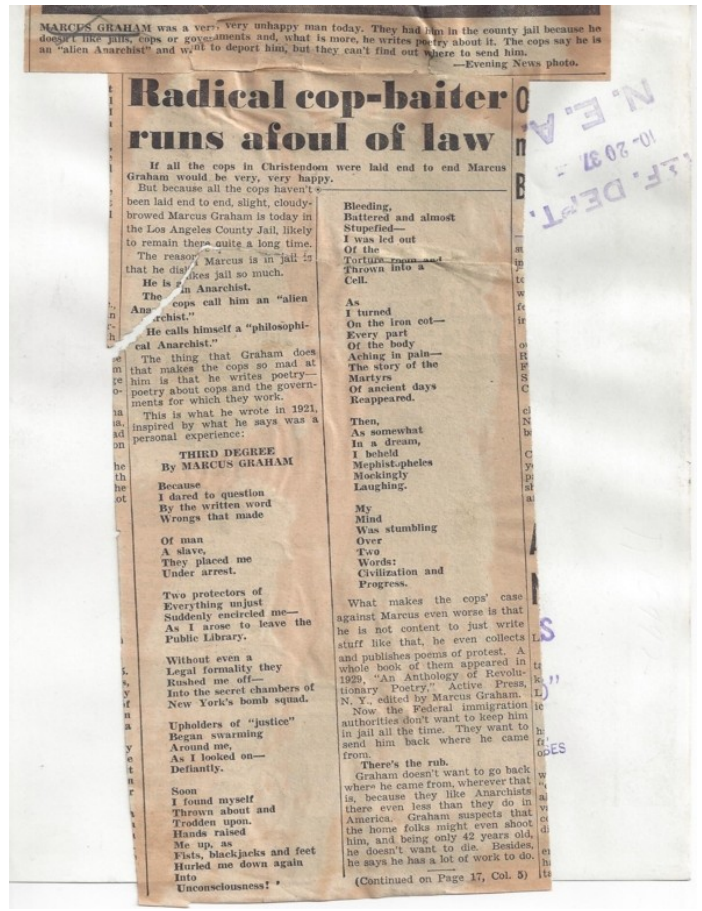
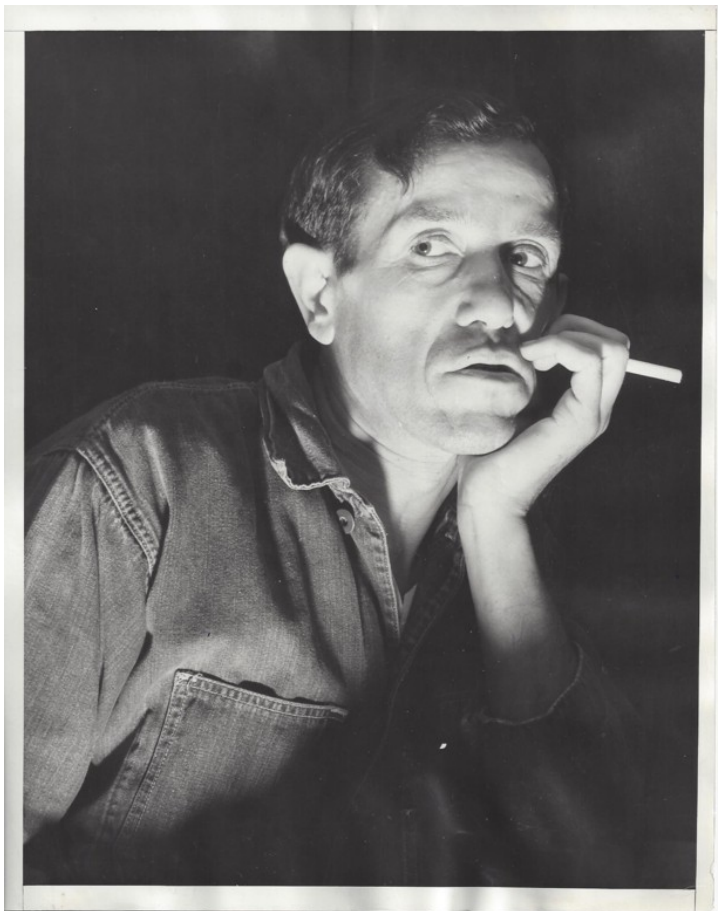
16. **[Eugene Debs] Press Photo of Mr. and Mrs. Eugene Debs.** New York: Acme Newspictures (Newspaper Enterprise Association), April 24, 1926. Press photo, 16.6 by 21.6 cm. Very good with crop marks and light touch-ups; pencil notes, agency stamps and caption on verso. Caption reads: "HATS OFF TO THE STATUE OF LIBERTY!! Mr. and Mrs. Eugene Debs on board the S.S. Fort St. George coming into New York harbor after spending their vacation in Bermuda. The former candidate for president said, 'Bermuda is a fine place, but I'm glad to be back in America.' He will return to his farm in Indiana." \$45.00



17. **[Elisabeth Gilman] Six Press Photos of Elisabeth Gilman, American Socialist and Social Rights Activist.** From the archives of the Baltimore Sun, dated 1930-1936. All the images have touch-ups (aside from one) and light wear, with date stamps, pencil notes and name labels on verso. Included are: Portrait by Bachrach, dated July 19, 1930, 11.6 by 17 cm; Portrait, dated September 22, 1930, 20.2 by 25.2 cm; Portrait with dog by Bachrach, dated May 26, 1930, 20.2 by 25.8 cm, caption on rear reads "Miss Elisabeth Gilman / Candidate for Governor on Socialist ticket" (poor condition with tears, large chips, and pin-holes in the corners – see image); Gilman giving a speech, dated June 9, 1930, 22.2 by 25.3 cm (see detail on back cover of this list); Portrait, dated May 21, 1934, 22.3 by 25.7 cm; and a shot of Gilman with a basket of puppies, dated January 15, 1936, 18 by 24.8 cm. Gilman (1867-1950) was an American social and political activist. As a member of the Socialist Party of America she ran for Governor of Maryland in 1930, as well as the United States Senate in 1934 and '38. She was instrumental in the formation of the Maryland Civil Liberties Committee (a precursor of the ACLU), and adopted a non-interventionist, pacifist position when the Second World War appeared imminent. \$175.00



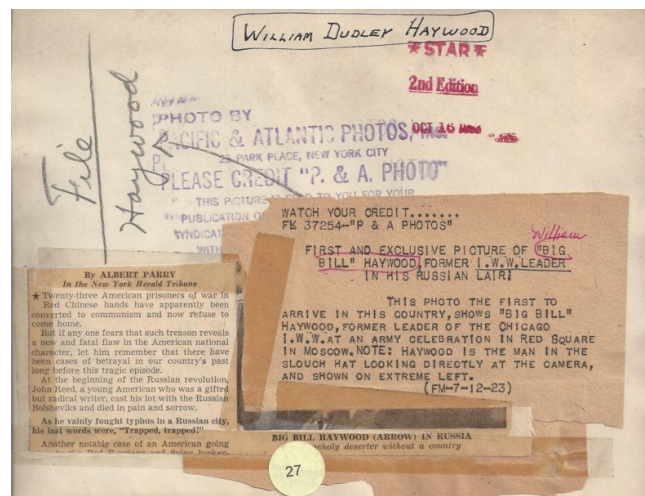
18. [Marcus Graham, Anarchist] Press Photo of Anarchist Poet Marcus Graham. NP: Newspaper Enterprise Association, October 20, 1937. Press photo, 17.9 by 22.8. Very good with light rippling near the bottom edge; agency stamp, caption and portion of news article affixed to verso. A wonderful image of the radical poet Graham. The article, titled "Radical cop-baiter runs afoul of law," includes his poem "Third Degree" where Graham writes about being beaten by police, "Because / I dare to question / By the written word / Wrongs that made / Of man / A slave, / They placed me / Under arrest..." The caption, as sarcastic as the article, reads: "Marcus Graham was a very, very unhappy man today. They had him in the county jail because he doesn't like jails, cops or governments and, what is more, he writes poetry about it. The cops say he is an 'alien Anarchist' and want to deport him, but they can't find out where to send him." Graham was the editor of *An Anthology of Revolutionary Poetry* (Active Press, 1929). \$65.00



19. [Che Guevara] Wire Photo of Che Guevara at United Nations. NP: Associated Press, December 10, 1964. Wire photo, 25.4 by 20.5 cm. Very good with light spotting and Che's name and date on verso. Caption reads: "NEW YORK, Dec. 10 -- DISTINGUISHED ON U.N. CHOW LINE -- Major Ernesto Che Guevara, bearded Cuban Minister of Industry who wears a green fatigue uniform, waits his turn to choose his lunch in the cafeteria at U.N. headquarters in New York today. He later joined others of the Cuban delegation at a table. Guevara, who is scheduled to speak tomorrow in the General Assembly, was asked by a newsmen if the U.N. could do anything to improve Cuban-U.S. relations. He replied, 'Nothing.'" The following day Che delivered an impassioned speech condemning the U.N. for their inaction in dealing with the "brutal policy of apartheid" in South Africa and spoke out against the United States for their treatment of black Americans, "Those who kill their own children and discriminate daily against them because of the color of their skin; those who let the murderers of blacks remain free, protecting them, and furthermore punishing the black population because they demand their legitimate rights as free men—how can those who do this consider themselves guardians of freedom?" \$35.00



20. [Bill Haywood, I.W.W.] Press Photo of Big Bill Haywood in Russia. New York: Pacific & Atlantic Photos, July 12, 1923. Press photo, 21.6 by 16.7 cm. Very good with a paper arrow pasted on the image to point out Haywood, and a veritable collage of agency stamps, notes and press clippings on verso. A rare image of Big Bill in Russia, where he fled to avoid prison in connection with charges of "conspiring to hinder the draft, encourage desertion, and intimidate others in connection with labor disputes." Haywood was a founding member of the International Workers of the World as well as being involved with the Western Federation of Miners and the Socialist Party of America. The caption reads: "First and Exclusive Picture of 'Big Bill' Haywood, Former I.W.W. Leader, in His Russian Lair! This photo, the first to arrive in this country, shows 'Big Bill' Haywood, former leader of the Chicago I.W.W., at an army celebration in Red Square in Moscow." \$60.00





21. [Bill Haywood, I.W.W.] **Press Photo of Big Bill Haywood.** NP: Newspaper Enterprise Association, December 16, 1926. Press photo, 12.7 by 20.2 cm. Very good with heavy touch-ups, a scratch across Haywood's abdomen (the scratch is from the negative), and notes and N.E.A. stamp on verso. Arguably the most famous image of Big Bill. \$35.00

22. [Joseph Labadie, Anarchist, Michigan] **Press Photo of Joseph Labadie.** NP: No publisher, April 3, 1936. Press photo, 20.5 by 25.6. Very good with crop marks near Jo's face and notes on the print, with pencil notes and a date stamp on verso. Apparently printed from a broken glass negative, you can see the cracks in this print. Date stamped 1936 on the back, with a date of July 24, 1911 on the negative. Jo Labadie was a Michigan labor organizer, social activist and anarchist. While he was involved with the Socialist Labor Party in Detroit and organized Detroit's first assembly of the Knights of Labor, he is probably best known for his massive archive of radical materials, the Labadie Collection, now held by the University of Michigan. \$75.00



23. **[Puerto Rico] Wire Photo of the Young Lords Party – Call for Puerto Rican Freedom.** NP: Associated Press, June 7, 1970. Wire photo, 28 by 20.2 cm. Very good, verso blank. The caption reads: “NEW YORK, June 7 – YOUNG LORDS CALL FOR PUERTO RICAN FREEDOM \_ Members of the militant ‘Young Lords’ drag an effigy of American Imperialism, foreground, and burn an American Flag, background, as they pass reviewing stand before New York City’s Metropolitan Museum Sunday during a Puerto Rican Day parade. Members of the group also chanted and carried signs and banners calling for independence of the island commonwealth.” A scarce image of Young Lords Party members, the photo is similar to the image on pages 98/99 of Michael Abramson’s book *Palante: Young Lords Party* (McGraw-Hill, 1971). \$85.00

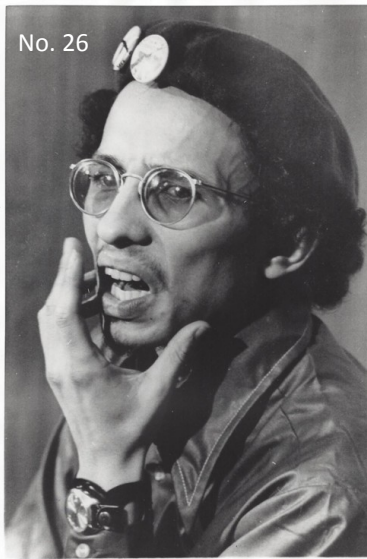


24. **[Red Army Faction] Wire Photo of Irmgard Möeller, Member of the Red Army Faction.** New York: Keystone Press Agency, October 17, 1977. Wire photo, 19 by 25.2 cm. Very good with caption and agency stamp on verso. Caption reads: “Andreas Baader, 37, leader of the Red Army faction, the terrorist gang also known as the Baader-Meinhoff group, and Gudrun Ensslin, 37, who became co-leader after the suicide in prison last year of Ulrike Meinhof, both shot themselves in prison today. So did another member of the gang, Jan-Carl Raspe. Irmgard Möeller also tried to kill herself by stabbing a knife in her heart. All except Moeller were serving life for terrorist offences in the maximum security prison at Stammheim, she was only serving four-and-a-half years for being a member of a terrorist group.” A classic, if grainy image of Möeller. \$20.00



25. **[Ben Reitman] Press Photo of Ben Reitman, Hobo Physician.** NP: No publisher, November 26, 1924. Press photo, 15.4 by 25.2 cm. Fair with rough edges, a chip from the upper left corner and lower corners cut off (see image). Pencil notes, date and “deceased” stamp on verso. The touch-ups are on the original print, from which this image was taken. Quite a scarce shot of the “Hobo Physician” and founder of the Hobo College in Chicago. Reitman (1879-1942) was an anarchist who dedicated his life to caring for social outcasts, including hobos, prostitutes, the homeless, and the poor, as well as his fellow radicals. He was a lover of Emma Goldman and the pair travelled the country promoting legal abortions and birth control (for which he went to prison for six months). \$90.00

26. **[Republic of New Afrika] Wire Photo of Rafael Viera.** New York: United Press International/Newspaper Enterprise Association, October 30, 1970. Wire photo, 20.5 by 25.3 cm. Very good with agency stamps on verso. Viera was a member of the Republic of New Afrika (RNA) that advocated for the creation of an independent African-American-majority country within the United States. He was charged, tried and acquitted of murdering a policeman in 1969 during the first New Afrikan Nation Day Celebration at the New Bethel Baptist Church, on the West Side of Detroit. The caption reads: “10/30/70 – DETROIT: Rafael Viera, 22, co-defendant in the New Bethel trial with Clarence J. Fuller, who was stabbed to death 10/26, said 10/29 at a news conference that two recent attempts had been made on his life. Viera and Fuller were charged in the rifle shooting 3/29/69 of two Detroit policemen, Michael Czapski, who was killed,

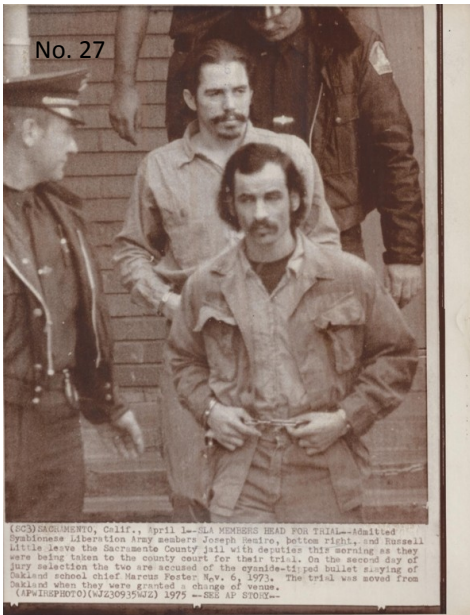

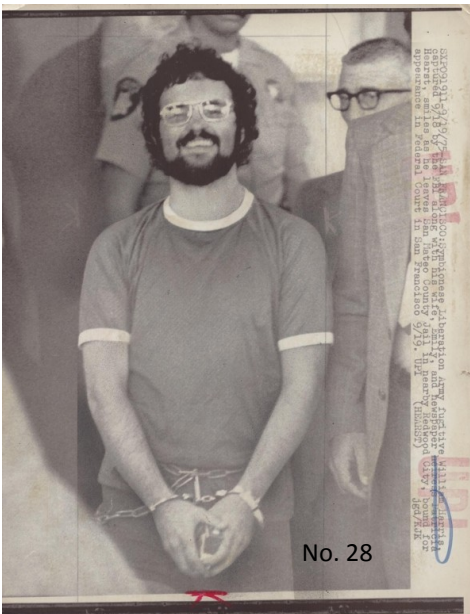

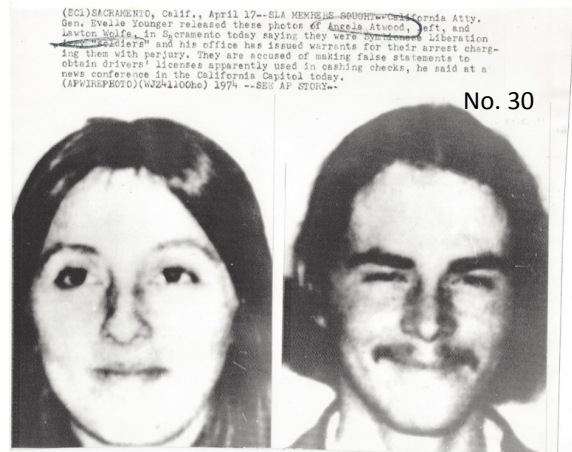

The man at the top left has not yet been identified but the three women, who have been linked to the terrorist Symbionese Liberation Army were identified by the FBI as, top right, Camelia Hall, lower left, Patricia Soltysik and, bottom right, Nancy Ling Perry. 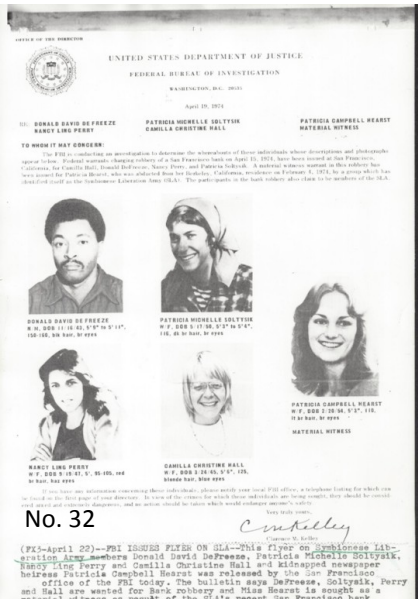

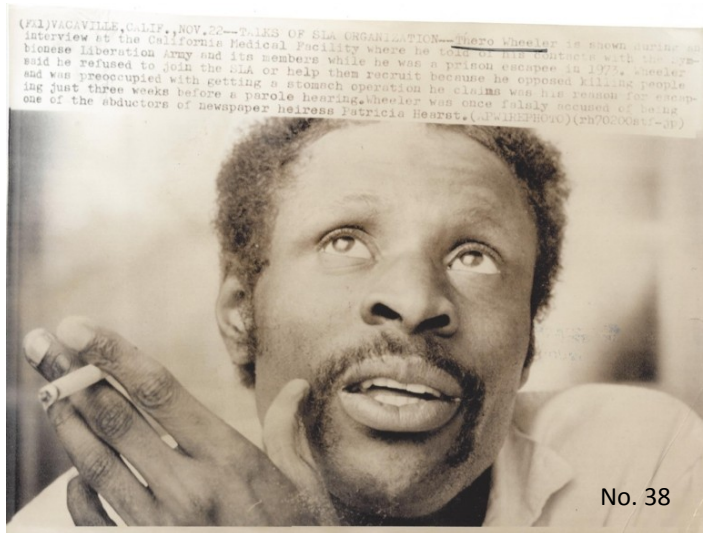

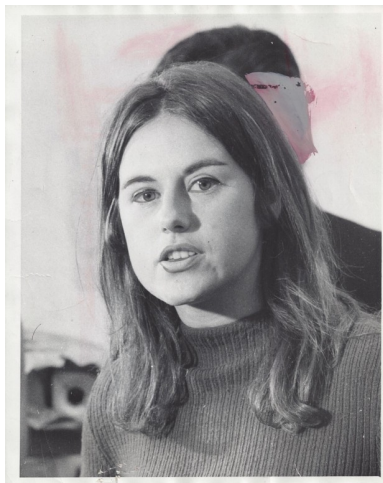
