




First edition. Anquetil-Duperron (1731-1805) was an important orientalist and interpreter of the French king. This curious and rare work is a vehement attack against the disparagement of commerce at his time and the negative consequences of this attitude for the French economy and society.

In 1946, with the help of his friend F.A. von Hayek, he became a Reader in Logic and Scientific Method at the London School of Economics. Popper's main work is a masterly criticism and attack on totalitarianism. He dedicated it to the millions who have been sacrificed to the doctrine of Historical Inevitability, and his defense of democracy against its totalitarian opponents involves not only a respect for facts and a determination to discover them but also a determination to recognize that human beings cannot be made perfect by decree of a society invented from which conflict is absent (**Thinkers of the Twentieth Century**, p. 455).
